ORDINANCE NO. 2023-593**

“An Ordinance Amending and Restating Stop Intersections Established”

AN ORDINANCE AMENDING THE CODE OF ORDINANCES OF THE BOROUGH OF RED HILL, CHAPTER 15 (MOTOR VEHICLES AND TRAFFIC), PART 2 (TRAFFIC REGULATIONS), 15-213 (STOP INTERSECTIONS ESTABLISHED) BY DELETING THE EXISTING SECTION 15-213 IN ITS ENTIRETY AND REPLACING IT WITH A NEW AMENDED AND RESTATED SECTION 15-213 IN ORDER TO UPDATE THE LIST OF ESTABLISHED STOP SIGNS.

The Borough Council of the Borough of Red Hill does hereby **ENACT** and **ORDAIN** as follows:

SECTION I. - Amendment to Code

The Code of Ordinances of the Borough of Red Hill, Chapter 15 (Motor Vehicles and Traffic), Part 2 (Traffic Regulations), is hereby amended by deleting the existing Section 15-213 (Stop Intersections Established) and adding a new Section 15-213 (Stop Intersections Established) as follows:

§ 15-213 Stop Intersections Established.

1. The following intersections (in addition to intersections with the through highways established by § 15-212) are established as stop intersections, and official stop signs shall be erected (or are ratified if previously erected) in such a position as to face traffic approaching the second-named street (the intersecting or through street) on the first-named street (the stop street) in the direction or directions indicated for that intersection. Every driver of a vehicle approaching the intersection on the first-named or stop street, in the direction indicated in each case, shall stop the vehicle as required by § 3323(b) of the Vehicle Code, and shall not proceed into or across the second-named or intersecting or through street until he has followed all applicable requirements of that Section of the law.

SECTION II. - Severability

The provisions of this Ordinance are intended to be severable, and if any section, sentence, clause, part or provision hereof shall be held illegal, invalid or unconstitutional by any court of competent jurisdiction, such decision of the court shall not affect or impair the remaining sections, sentences, clauses, parts or provisions of this Ordinance. It is hereby declared to be the intent of the Council that this Ordinance would have been adopted even if such illegal, invalid or unconstitutional section, sentence, clause, part or provision had not been included herein.

SECTION III. -Failure to enforce not a Waiver

The failure of the Borough to enforce any provision of this Ordinance shall not constitute a waiver by the Borough of its rights of future enforcement hereunder.

SECTION IV. - Effective Date


This Ordinance shall take effect and be in force from and after its approval as required by the law.

SECTION V. - Repealer

All other ordinances and resolutions or parts thereof insofar as they are inconsistent with this Ordinance are hereby repealed.
