**ORDINANCE NO. 2023-594**

**“Motor Vehicle and Traffic Ordinance Amendments”**

**AN ORDINANCE AMENDING THE CODE OF ORDINANCES OF THE BOROUGH OF RED HILL, CHAPTER 15 (MOTOR VEHICLES AND TRAFFIC), PART 2 (TRAFFIC REGULATIONS), SECTION 15-213 (STOP INTERSECTIONS ESTABLISHED) TO ADD THE STOP SIGN LOCATED AT THE EMERGENCY ACCESS ROAD TO THE HIGH SCHOOL AT ITS INTERSECTION WITH WEST EIGHT STREET; AND AMENDING PART 4 (GENERAL PARKING REGULATIONS), SECTION 15-403.A (PARKING PROHIBITED AT ALL TIMES IN CERTAIN LOCATIONS) TO CHANGE THE LOCATION FOR CERTAIN STREETS AND ADD ADDITIONAL STREETS TO THE EXISTING LIST.**

The Borough Council of the Borough of Red Hill does hereby **ENACT** and **ORDAIN** as follows:

**SECTION I. - Amendment to Code.**

The Code of Ordinances of the Borough of Red Hill, Chapter 15 (Motor Vehicles and Traffic), Part 2 (Traffic Regulations), Section 15-213 (Stop Intersections Established) is hereby amended to add a stop sign located at the Emergency Access Road to the High School at its intersection with West Eighth Street to the existing list as follows:

**§ 15-213 Stop Intersections Established.**

Street	Intersection or Through Street	Direction of Travel
Emergency Access Road	Eighth Street	South

**SECTION II. - Amendment to Code.**

The Code of Ordinances of the Borough of Red Hill, Chapter 15 (Motor Vehicles and Traffic), Part 4 (General Parking Regulations), Section 15-403 (Parking Prohibited at All Times in Certain Locations) is hereby amended to change the location for certain streets as follows:

§ 15-403 **Parking Prohibited at All Times in Certain Locations.**

Third Street, East	North	Intersection with Main Street a distance of 86 feet East
Third Street, East	South	Intersection with Main Street a distance of 115 feet East
Fourth Street, East	North	Main Street to Bitting Alley
Fifth Street, East	Both	Main to Bitting Alley
Fifth Street, East	North	Intersection with Bitting Alley for a distance of 363 feet East
Sixth Street, East	North	Main Street to Washington Street
Sixth Street, East	North	Main Street to Washington Street
Sixth Street, East	South	Main Street for a distance of 288 feet East
Seventh Street, East	North	Main Street to Bitting Alley
Eighth Street, East	North	Main Street to Bitting Alley
Eleventh Street, East	South	Intersection with Main Street a distance of 72 feet East
Main Street	East	Starting at a point 508 feet north of East Second Street for a distance of 238 feet North
Main Street	East	Intersection with East Third Street a distance of 127 feet North
Main Street	East	Intersection with East Fourth Street a distance of 254 feet North
Main Street	East	Intersection with East Fourth Street a distance of 173 feet South
Main Street	East	Intersection with East Sixth Street a distance of 338 feet North
Main Street	East	Intersection with East Sixth Street a distance of 256 feet South
Main Street	East	Intersection with East Eleventh Street a distance of 725 feet South

**SECTION III. - Amendment to Code.**

The Code of Ordinances of the Borough of Red Hill, Chapter 15 (Motor Vehicles and Traffic), Part 4 (General Parking Regulations), Section 15-403 A (Parking Prohibited at All Times in Certain Locations) by adding the following to the list of Parking Prohibited at All Times in Certain Locations as follows:

**§ 15-403 Parking Prohibited at All Times in Certain Locations.**

<b>STREET</b>	<b>SIDE</b>	<b>LOCATION</b>
Second Street, East	North	Intersection with Main Street a distance of 59 feet East
Second Street, East	South	Intersection with Main Street A distance of 58 feet East
Fourth Street, East	South	Intersection with Main Street A distance of 59 feet East
Eighth Street, East	South	Intersection with Main Street a distance of 60 feet East
Main Street	East	Intersection with East Sixth Street a distance of 256 feet South
Main Street	East	From the intersection of East Second Street for a distance 84 feet North

**SECTION IV. – Severability.**

The provisions of this Ordinance are intended to be severable, and if any section, sentence, clause, part, or provision hereof shall be held illegal, invalid, or unconstitutional by any court of competent jurisdiction, such decision of the court shall not affect or impair the remaining sections, sentences, clauses, parts, or provisions of this Ordinance. It is hereby declared to be the intent of the Council that this Ordinance would have been adopted even if such illegal, invalid, or unconstitutional section, sentence, clause, part, or provision had not been included herein.

**SECTION V. -Failure to enforce not a Waiver.**

The failure of the Borough to enforce any provision of this Ordinance shall not constitute a waiver by the Borough of its rights of future enforcement hereunder.

**SECTION VI. - Effective Date.**

This Ordinance shall take effect and be in force from and after its approval as required by the law.

**SECTION VII. – Repealer.**

All other ordinances and resolutions or parts thereof insofar as they are inconsistent with this Ordinance are hereby repealed.
