ORDINANCE NO. 2640

AN ORDINANCE TEMPORARILY SUSPENDING THE APPLICABILITY OF CHAPTER 406 OF THE MUNICIPAL CODE OF ORDINANCES OF THE CITY OF RICHMOND, MISSOURI, TO A DESIGNATED OVERFLOW PARKING AREA FOR A SPECIAL CONCERT EVENT AT 724 WOLLARD BOULEVARD ON APRIL 27, 2024.

WHEREAS, Ordinance No. 2612 adopted by the City Council of the City of Richmond, Missouri (the "City") approved a conditional use permit for an outdoor theater located at 724 Wollard Boulevard in the City; and

WHEREAS, Section II, paragraph 10 of said Ordinance requires compliance with the parking regulations included in Chapter 406 of the Municipal Code of Ordinances of the City of Richmond, Missouri ("the City Code") for events at said outdoor theater; and

WHEREAS, the operator of the outdoor theater has requested that compliance with the requirements of Chapter 406 of the City Code be temporarily suspended on April 27-28, 2024, for overflow parking of tour buses, recreational vehicles, and attendees of a special concert event on April 27, 2024, in a designated, unpaved area as shown on the map attached hereto as Exhibit A; and

WHEREAS, the City Council desires to suspend the applicability of the parking regulations included in Chapter 406 of the City Code as described herein.

NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF RICHMOND, MISSOURI, AS FOLLOWS:

SECTION I.

That the requirement in Ordinance No. 2612 regarding the applicability of the parking regulations in Chapter 406 of the City Code shall be temporarily suspended on April 27-28, 2024, for overflow parking of tour buses, recreational vehicles, and attendees of a special concert event on April 27, 2024, in a designated, unpaved area as shown on the map attached hereto as Exhibit A and incorporated herein by reference.

SECTION II.

This ordinance shall take effect and be in force and effect from and after its passage by the City Council and signing into law by the Mayor of the City of Richmond, Missouri.


