

ORDINANCE NO. 2504

**ROSS TOWNSHIP
ALLEGHENY COUNTY, PENNSYLVANIA**

AN ORDINANCE OF THE TOWNSHIP OF ROSS, ALLEGHENY COUNTY, PENNSYLVANIA, AMENDING CHAPTER 1, ADMINISTRATION AND GOVERNMENT, PART 10, BOARDS, OF THE ROSS TOWNSHIP CODE OF ORDINANCES, TO REPEAL SECTION 1-1002 OF ORDINANCE NO. 2342, TRAFFIC ADVISORY BOARD.

WHEREAS, pursuant to section 1502.44 of the Pennsylvania First Class Township Code, 53 P.S. § 56544, the Board of Commissioners has the authority to enact and amend provisions of the Code of Ordinances of Ross Township (hereinafter the "Code") at any time it deems necessary for the health, safety, morals, cleanliness, beauty, convenience, comfort and general welfare of the Township and the inhabitants thereof; and

WHEREAS, the Board of Commissioners of Ross Township (the "Township") deems it necessary to amend the Code to promote and protect the health, safety and welfare of the residents of the Township, the Township Board of Commissioners has determined, upon the recommendation of the Township Chief of Police, it necessary to REPEAL Section 1-1002 of Ordinance No. 2342 in its entirety.

NOW THEREFORE, BE IT ORDAINED AND ENACTED BY THE BOARD OF COMMISSIONERS OF ROSS TOWNSHIP, ALLEGHENY COUNTY PENNSYLVANIA AND IT IS HEREBY ORDAINED AND ENACTED BY AND WITH THE SAME THAT:

SECTION 1:

The aforementioned Title/Summary and WHEREAS clauses are incorporated by reference, the same as if fully set forth herein at length.

SECTION 2:

Section 1-1002 of Ordinance No. 2342, Traffic Advisory Board, is hereby REPEALED in its entirety.

SECTION 3:

The appropriate Officers of the Township are hereby authorized and directed to take such actions and execute any and all documents necessary to effectuate the purposes of this Ordinance.

SECTION 4:

In the event that any section, sentence, clause, phrase or word of this ordinance shall be declared illegal, invalid, or unconstitutional by any Court of competent jurisdiction, such declaration shall not prevent or otherwise foreclose enforcement of any of the remaining provisions of this ordinance.

SECTION 5:

All ordinances or parts of ordinances inconsistent herewith or in conflict with any of the specific terms enacted hereby, each such inconsistency or conflict is hereby specifically repealed.
