AN ORDINANCE AMENDING AND SUPPLEMENTING CHAPTER 2 OF THE REVISED GENERAL ORDINANCES OF THE BOROUGH OF ROSELAND ENTITLED "ADMINISTRATION", AMENDING SECTION 2-6 ENTITLED "STANDING COMMITTEES OF THE BOROUGH COUNCIL"

**BE IT ORDAINED** by the Mayor and Council of the Borough of Roseland, County of Essex, State of New Jersey as follows:

**SECTION I**

That section 2-6 entitled "Standing Committees of the Borough Council" shall be amended by adding the following **thus** and deleting the following **thus**:

**§ 2-6 STANDING COMMITTEES OF THE BOROUGH COUNCIL.**

**§ 2-6.1 Standing Committees Designated.**

~~The Borough Council of the Borough of Roseland shall adopt a resolution annually at its Reorganization Meeting designating the Standing Committees of Council of the Borough of Roseland for that year. The administration of all Borough departments, offices, boards, committees and commissions shall be conducted by the following Standing Committees of the Borough Council:~~

- ~~a. — Finance and Administration;~~
- ~~b. — Public Works;~~
- ~~c. — Public Safety;~~
- ~~d. — Recreation;~~
- ~~e. — Community Outreach and Shared Services;~~
- ~~f. — Redevelopment and Legal.~~

**§ 2-6.2 Appointment of Members to the Standing Committees of Council.**

~~Pursuant to N.J.S.A. 40A:60-7, the The members of the Standing Committees of Council shall be appointed annually by the mayor with the advice and consent of Council. shall, by a vote of a majority of its members, appoint all Committee members to the Standing Committees of Council.~~

~~§ 2-6.3 Authority of Standing Committees.~~

~~a. The administration of the departments, offices, boards, committees and commissions shall be assigned to the respective Council Committees as follows in the following manner:~~

~~1. The Council Committee on Finance and Administration shall be responsible for the administration of the Department of Administration, the Department of Finance, the Office of Borough Attorney and such other offices, boards, committees or commissions as shall be assigned to it by the Mayor, with the advice and consent of Council.~~

~~2. The Council Committee on Public Works shall be responsible for the administration of the Department of Public Works, the Office of Borough Engineer and such other offices, boards, committees or commissions as shall be assigned to it by the Mayor, with the advice and consent of Council.~~

~~3. The Council Committee on Public Safety shall be responsible for the administration of the Department of Police, First Aid Squad, Fire Department, Fire Prevention Bureau, Office of Emergency Management and such other offices, boards, committees or commissions as shall be assigned to it by the Mayor, with the advice and consent of Council.~~

~~4. The Council Committee on Recreation shall be responsible for the Department of Recreation, Parks and Playgrounds, the Recreation Committee and such other offices, boards, committees or commissions as shall be assigned to it by the Mayor, with the advice and consent of Council.~~

~~5. The Council Committee on Community Outreach and Shared Services shall be responsible for evaluating shared service opportunities and making recommendations to better share resources across neighboring municipalities; and shall be responsible for such other offices, boards, committees or commissions as shall be assigned to it by the Mayor, with the advice and consent of the Council.~~

~~6. The Council Committee on Redevelopment and Legal shall be responsible for evaluating and recommending redevelopment opportunities, and the administration of all offices, boards, committees and commissions which may be assigned to it by the Mayor, with the advice and consent of Council.~~

~~b. Each Standing Committee of the Borough Council shall be composed of three members of the Council appointed at the annual organization meeting, to serve until the next annual organization meeting of the Council. The Council shall elect one of its members to be appointed Chairperson.~~

~~e. The offices, boards, committees and commissions which have not been specifically assigned to any standing Council Committee under the provisions of this subsection shall be assigned to Standing Council Committees at the annual organization meeting by the Mayor, with the advice and consent of Council.~~

**SECTION II**

If any section of provision of this ordinance shall be invalid in any court the same shall not affect the other sections or provisions of this ordinance except so far as the section or provision so declared invalid shall be inseparable from the remainder or any portion thereof.

**SECTION III**

All ordinances or parts of ordinances inconsistent herewith are hereby repealed to the extent of such inconsistency.

**SECTION IV**

This ordinance shall take effect in accordance with applicable law.
