ORDINANCE NO. 1968

**AN ORDINANCE OF THE TOWNSHIP OF SHALER,
ALLEGHENY COUNTY, PENNSYLVANIA, AMENDING
CHAPTER 212 OF THE CODE OF SHALER TOWNSHIP,
VEHICLES AND TRAFFIC, TO PROHIBIT PARKING
ALONG THE WESTERN SIDE OF KOEHLER STREET
WITHIN THE TOWNSHIP AND TO ERECT “NO PARKING
SIGNS” AS REQUIRED PURSUANT TO THE
PENNSYLVANIA MOTOR VEHICLE CODE.**

WHEREAS, The Pennsylvania First Class Township Code, 53 P.S. §56579.24, authorizes Shaler Township (“Township”) by and through its Board of Commissioners (“Board”) to regulate parking within the Township; and

WHEREAS, Chapter 61 of the Pennsylvania Motor Vehicle Code, 75 Pa. C.S. §6101 *et seq.* (“Vehicle Code”) authorizes the Town to exercise, by ordinance, certain powers pertaining to the operation of motor vehicles on highways within its boundaries, including the power to make certain regulations regulating or prohibiting stopping, standing or parking; and

WHEREAS, the Township had adopted Code Chapter 212 of the Township Code of Ordinances, Vehicles and Traffic, which provides regulations for vehicles and traffic in the Township.

WHEREAS, the Board has reviewed a location within the Town, identified as Koehler Street, and determined that a prohibition of parking along the south-bound side of Koehler Street for its duration until terminus at Friday Road, is in the best interests of the Town residents and will improve pedestrian and vehicular safety as well as traffic control and circulation within the Town; and

WHEREAS, the Board desires to amend Section 212-58, Schedule XII: Parking Prohibited at All Times, to prohibit parking and erect “No Parking” signs along the southbound lane of Koehler Street; and

NOW THEREFORE, the Board of Supervisors of Shaler Township, Allegheny County, Pennsylvania hereby ordains and enacts as follows, incorporating the above recitals by reference:

SECTION 1. Section 212-58, Schedule XII: Parking Prohibited at All Times, is hereby amended by inserting the underlined terms as follows:

§212-58 **Parking prohibited at all times.**

In accordance with the provisions of § 212-23, no person shall park a vehicle at any time upon any of the following described streets or parts of streets:

Name of Street

Location

Koehler Street

Western Side from Manhattan Ave. to Friday Road.

SECTION 2. The Board hereby authorizes any and all appropriate Township officials or staff to take any and all actions necessary to install “No Parking” signage along the western side of Koehler Street from Manhattan Ave to Friday Road in such number in at such intervals as deemed reasonably necessary to provide sufficient notice of the parking restrictions established by Section 212-58, and to take any additional actions required to effectuate these changes.

SECTION 3. Should any sentence, section, clause, part or provision of this Ordinance be declared by a court of competent jurisdiction to be invalid, the same shall not affect the validity of the Ordinance as a whole, other than the part declared to be invalid.

SECTION 3. All prior ordinances are hereby repealed in whole or in part to the extent inconsistent herewith.

SECTION 4. This Ordinance shall take effect in accordance with applicable law.
