**A RESOLUTION OF SHREWSBURY TOWNSHIP AMENDING RESOLUTION
NO. 2023-08 FOR THE AUTHORIZATION TO SUBMIT AN APPLICATION FOR
THE LOCAL SHARE ACCOUNT FUND (GAMING FUNDS)
STATEWIDE GRANT PROGRAM.**

WHEREAS, Shrewsbury Township, York County, Pennsylvania, is a municipality existing under the laws of the Commonwealth of Pennsylvania (the "Township"); and

WHEREAS, the Township submitted a grant application in November 2023 under the Local Share Account Fund (Gaming Funds) Statewide grant program for the construction of a pavilion at Windy Hill Park; and

WHEREAS, the project budget has been corrected and amended, and has increased from \$177,500.00 to \$294,874.00, and the grant request increased from \$150,000.00 to \$220,000.00, with the Township matching funds increasing from \$27,500.00 to \$74,874.00; and

WHEREAS, the purpose of this resolution is to reauthorize Shrewsbury Township to make an amended application to the Pennsylvania Department of Community and Economic Development (DCED) for funding a portion of the cost to construct a pavilion at Windy Hill Park; and

WHEREAS, this resolution further reauthorizes Arthur Rutledge, Chairman of the Board of Supervisors, and Todd A. Zeigler, Township Manager, to execute a grant agreement, and any other grant related documents.

NOW, THEREFORE, BE IT RESOLVED, by Shrewsbury Township, and it is hereby resolved by the Shrewsbury Township Board of Supervisors, authorizing submission of a corrected and amended budget & application to DCED for a grant to construct a pavilion at Windy Hill Park, and that Arthur Rutledge, Chairman of the Board of Supervisors, and Todd A. Zeigler, Township Manager, are authorized to take any and all other necessary actions to effectuate submittal of the grant application.


