

**ORDINANCE NO. 2021-24**  
**AN ORDINANCE OF THE BOROUGH OF SOUTH RIVER, COUNTY OF MIDDLESEX,**  
**STATE OF NEW JERSEY, AMENDING THE BOROUGH CODE OF THE BOROUGH OF**  
**SOUTH RIVER, SO AS TO AMEND CHAPTER 72 ENTITLED "PUBLIC SAFETY,**  
**DEPARTMENT OF"**

**BE IT ORDAINED** by the Mayor and Borough Council of the Borough of South River, County of Middlesex, and State of New Jersey, as follows:

**SECTION 1.** Chapter 72 of the Borough Code of the Borough of South River, entitled "Public Safety, Department of" is hereby amended so as to delete Section 72-19 entitled "Deputy Chief of Police" in its entirety.

**SECTION 2.** All ordinances or parts of ordinances inconsistent herewith are hereby repealed.

**SECTION 3.** If any section, subsection, sentence, clause, phrase or portion of this ordinance is for any reason held to be invalid or unconstitutional by a court of competent jurisdiction, such portion shall be deemed a separate, distinct and independent provision, and such holding shall not affect the validity of the remaining portions hereof.

**SECTION 4.** This ordinance shall take effect after second reading and publication as required by law.
