

ORDINANCE NO. 2022-04
AN ORDINANCE OF THE BOROUGH OF SOUTH RIVER, COUNTY OF MIDDLESEX, STATE OF NEW JERSEY, AMENDING THE BOROUGH CODE OF THE BOROUGH OF SOUTH RIVER, SO AS TO AMEND CHAPTER 193 ENTITLED "VEHICLES AND TRAFFIC"

BE IT ORDAINED by the Mayor and Borough Council of the Borough of South River, County of Middlesex, and State of New Jersey, as follows:

SECTION 1. Chapter 193 of the Borough Code of the Borough of South River, entitled "Vehicles and Traffic," is hereby amended and supplemented so as to amend Schedule IV (§ 193-33) entitled, "Schedule I: Parking time limited," so as to add the following street:

| Name of Street | Side | Hours | Maximum Time | Location |
|-----------------------|-------------|-------------------------------------|---------------------|---|
| Hillside Avenue | East | 8:00 am- 5:00 pm Monday - Friday | 30 minutes | 51 feet south from the intersection of Main Street, continuing 44 feet Thereof. |

SECTION 2. All ordinances or parts of ordinances inconsistent herewith are hereby repealed.

SECTION 3. This ordinance shall take effect after second reading and publication as required by law.
