

**ORDINANCE 2022-06  
AN ORDINANCE REPEALING ORDINANCE 2000-15 CREATING A HANDICAPPED  
PARKING SPACE AT HOLMES AVENUE**

**WHEREAS**, the governing body previously created handicapped parking space on Holmes Avenue, which is no longer required.

**NOW THEREFORE BE IT ORDAINED** by the Mayor and Borough Council of the Borough of South River as follows:

**SECTION 1.** Ordinance 2000-15 creating a handicapped parking space on Holmes Avenue, from a point 316' south of Jackson Street (west side), is hereby repealed.

**SECTION 2.** If any section, paragraph, subdivision, clause of provision of this Ordinance shall be adjudged invalid, such adjudication shall apply only to the section, paragraph, subdivision, clause, or provision so adjudged and the remainder of the Ordinance shall be deemed valid and effective.

**SECTION 3.** All Ordinances or parts of Ordinances inconsistent with or in conflict with this Ordinance are hereby repealed to the extent of such inconsistency.

**SECTION 3.** This Ordinance shall take effect after final passage, adoption, and publication according to law.
