

**ORDINANCE NO. 2022 -08**  
**AN ORDINANCE OF THE BOROUGH OF SOUTH RIVER, COUNTY OF MIDDLESEX,**  
**STATE OF NEW JERSEY, AMENDING THE BOROUGH CODE OF THE BOROUGH OF**  
**SOUTH RIVER, SO AS TO AMEND CHAPTER 155 ENTITLED "FEES"**

BE IT ORDAINED by the Mayor and Borough Council of the Borough of South River, County of Middlesex, and State of New Jersey, as follows:

**SECTION 1.** Chapter 155 of the Borough Code of the Borough of South River, entitled "Fees"

is hereby amended so as to add Section 155-34 entitled "Chapter 120, Cannabis fees" as follows:

**§ 155-34 Chapter 120, Cannabis fees**

- A. Suitability application fee: \$100.00
- B. Initial license application fee: \$200.00
- C. Each annual license renewal fee: \$25.00

**SECTION 2.** All ordinances or parts of ordinances inconsistent herewith are hereby repealed.

**SECTION 3.** If any section, subsection, sentence, clause, phrase or portion of this ordinance is for any reason held to be invalid or unconstitutional by a court of competent jurisdiction, such portion shall be deemed a separate, distinct and independent provision, and such holding shall not affect the validity of the remaining portions hereof.

**SECTION 4.** This ordinance shall take effect after second reading and publication as required by law.
