

**ORDINANCE NO. 2022-10**  
**AN ORDINANCE OF THE BOROUGH OF SOUTH RIVER, COUNTY OF MIDDLESEX, STATE OF NEW JERSEY, AMENDING THE BOROUGH CODE OF THE BOROUGH OF SOUTH RIVER, SO AS TO AMEND CHAPTER 193 ENTITLED "VEHICLES AND TRAFFIC"**

BE IT ORDAINED by the Mayor and Borough Council of the Borough of South River, County of Middlesex, and State of New Jersey, as follows:

**SECTION 1.** Chapter 193 of the Borough Code of the Borough of South River, entitled "Vehicles and Traffic," is hereby amended and supplemented so as to amend Schedule IV (§ 193-31) entitled, "Schedule II: No Parking Certain Hours," so as to add the following streets:

Name of Street	Side	Hours	Location
Montgomery St.	East	7:00 am- 8:30 pm Monday - Friday	200 feet south from the of Johnson Place, extending 44 feet thereof.

**SECTION 2.** Chapter 193 of the Borough Code of the Borough of South River, entitled "Vehicles and Traffic," is hereby amended and supplemented so as to amend Schedule IV (§ 193-33) entitled, "Schedule IV: Time Limit Parking," so as to remove the following streets:

Name of Street	Side	Hours	Maximum Time	Location
Montgomery St.	Northwest	7:00 am - 9:00 pm, School days	½ Hour	From a point 60 ft. South of the northwest Curbline of Johnson Place to a point of 562 ft. South thereof.

**SECTION 3.** All ordinances or parts of ordinances inconsistent herewith are hereby repealed.

**SECTION 4.** This ordinance shall take effect after second reading and publication as required by law.
