ORDINANCE NO. 2022 -12

AN ORDINANCE OF THE BOROUGH OF SOUTH RIVER, COUNTY OF MIDDLESEX, STATE OF NEW JERSEY, AMENDING THE BOROUGH CODE OF THE BOROUGH OF SOUTH RIVER, SO AS TO ADD CHAPTER 80 ENTITLED "RECREATION, DEPARTMENT OF"

BE IT ORDAINED by the Mayor and Borough Council of the Borough of South River, County of

Middlesex, and State of New Jersey, as follows:

SECTION 1.

Chapter 80 of the Borough Code of the Borough of South River, entitled

"Recreation, Department of" is hereby created to read entirely as follows:

Article 1 Scope of the Department

§ 80-1 Organization and Authority

There shall be a Department of Recreation in the Borough of South River under the supervision and control of the Recreation Director hereinafter created. The Recreation Director shall report directly to the Borough Administrator of the Borough of South River. The Department of Recreation shall exercise supervision and control over the Recreation Coordinator and the Assistant Recreation Coordinator and such other agencies, officers and employees as may be designated from time to time by the Borough Council. A member of the governing body shall be appointed as the Council Liaison to the Recreation Department.

Article 2: Recreation Director

§ 80-2 Creation of Position

The Recreation Director shall be either a full-time or part-time position as determined by the governing body and shall be appointed by the Mayor with the advice and consent of the Council. Said appointee shall serve at the pleasure of the governing body.

§ 80-3 Duties of Recreation Director

The Recreation Director shall be responsible for the planning, promotion, development and supervision of a community-wide program of recreation activities for various age groups in the Borough. The Recreation Director shall be required to do related work as directed by the Business Administrator. The Recreation Director plans, initiates, organizes and supervises an extensive program of recreation activities for the entire community. She/he supervises, trains, evaluates, and advises assigned recreation personnel.

Article 3: Recreation Coordinator

§ 80-4 Creation of Position

The Recreation Coordinator shall be either a full-time or part-time position as determined by the governing body and shall be appointed by the Mayor with the advice and consent of the Council. Said appointee shall serve at the pleasure of the governing body.

§ 80-5 Duties of Recreation Coordinator

Under the direction of the Recreation Director, the Recreation Coordinator shall be responsible for the planning, promotion, development, supervision and monitoring of a community-wide program of recreation activities for the Borough residents. The Recreation Coordinator shall also be able to disseminate information to the general public on recreation programs, prepare necessary correspondence, answer inquiries from the public regarding recreation programs and other duties as assigned by the Recreation Director.

Article 4: Recreation Assistant

§ 80-6 Creation of Position

The Recreation Assistant shall be either a full-time or part-time position as determined by the governing body and shall be appointed by the Mayor with the advice and consent of the Council. Said appointee shall serve at the pleasure of the governing body.

§ 80-7 Duties of Recreation Assistant

Recreation Assistant shall be required to do Recreation related work as directed by the Recreation Director or Recreation Coordinator.

SECTION 2. All ordinances or parts of ordinances inconsistent herewith are hereby repealed.

SECTION 3. If any section, subsection, sentence, clause, phrase or portion of this ordinance is for any reason held to be invalid or unconstitutional by a court of competent jurisdiction, such portion shall be deemed a separate, distinct and independent provision, and such holding shall not affect the validity of the remaining portions hereof.

SECTION 4. This ordinance shall take effect after second reading and publication as required by law.
