CAPITAL ORDINANCE NO. 2023-5

CAPITAL ORDINANCE PROVIDING FOR THE SITE REMEDIATION SERVICES FOR SOUTH RIVER FIREHOUSE AND APPROPRIATING \$65,441 THEREFOR FROM THE GENERAL CAPITAL FUND BALANCE, AUTHORIZED IN AND BY THE BOROUGH OF SOUTH RIVER, IN THE COUNTY OF MIDDLESEX, NEW JERSEY

WHEREAS, the Borough Council of the Borough of South River, in the County of Middlesex, New Jersey (the "Borough") has determined that additional site remediation services are needed for South River Firehouse site; and

WHEREAS, the Borough has \$65,441.00 available in the General Capital Fund Balance.

NOW, THEREFORE, BE IT ORDAINED by the BOROUGH COUNCIL OF THE BOROUGH OF SOUTH RIVER, IN THE COUNTY OF MIDDLESEX, STATE OF NEW JERSEY, AS FOLLOWS:

- Section 1. The improvements described in Section 2 of this ordinance are hereby authorized as general capital improvements to be undertaken in and by the Borough. For the improvements or purposes described in Section 2, there is hereby appropriated \$65,441.00, said sum being inclusive of \$65,441.00 from the General Capital Fund Balance.
- Section 2. The improvements hereby authorized to be undertaken consist of the site remediation services for the South River Firehouse, and including all related costs incidental thereto, and all work and materials necessary therefor and incidental thereto.
- Section 3. The 2023 capital budget of the Borough will conform with the provisions of this ordinance to the extent of any inconsistency herewith. The resolution in the form promulgated by the Local Finance Board showing full detail of the amended capital budget and capital program is on file with the Borough Clerk and is available there for public inspection.
- Section 4. An aggregate amount not exceeding \$65,441.00 for engineering costs, legal fees and other items of expense listed in and permitted under N.J.S.A. 40A:2-20 is included as part of the cost of said improvements and is included in the estimated cost indicated herein for said improvements.
- Section 5. All Borough officials and representatives are hereby authorized to do all things necessary to accomplish the purposes of the appropriation made herein.
 - Section 6. This ordinance shall take effect as provided by law.
