ORDINANCE NO. 2023 -22

AN ORDINANCE OF THE BOROUGH OF SOUTH RIVER, COUNTY OF MIDDLESEX, STATE OF NEW JERSEY, AMENDING THE BOROUGH CODE OF THE BOROUGH OF SOUTH RIVER, SO AS TO AMEND CHAPTER 155 ENTITLED "FEES"

BE IT ORDAINED by the Mayor and Borough Council of the Borough of South River, County of Middlesex, and State of New Jersey, as follows:

SECTION 1. Chapter 155 of the Borough Code of the Borough of South River, entitled "Fees" is hereby amended so as to amend Section 155.19.1 entitled "Section 22-62, Recreation program and park fees" as follows:.

§ 155.19.1 Section 22-62, Recreation program and park fees.

A. Baseball (t-ball, rookie, minor, major leagues): \$45.

Additional fees:

- (1) After registration closed: \$10.
- (2) For nonresidents: \$10.
- B. Basketball (fundamentals, K through 2, 3rd through 5th, 6th through 8th): \$60.

Additional fees:

- (1) After registration closed: \$10.
- (2) For nonresidents: \$10.
- C. Softball (gidgets, juniors, seniors): \$45.

Additional fees:

- (1) After registration closed: \$10.
- (2) For nonresidents: \$10.
- D. Wrestling: \$100.

Additional fees:

- (2) For nonresidents: \$10.
- E. Street hockey and Street Hockey Fundamentals: \$45.

F. Aerobics, men's fitness, zumba and yoga: \$30.

- G. Summer Recreation Early Dropoff Program.

- J. Athletic field lighting fees:
 - 1. When any sports team, league or organization seeks to reserve the use of a Borough athletic field at night(s), with the use of lighting, it shall be charged a lighting fee of \$25.00 per hour for the use of the electricity on lighted fields.
 - 2. Fees shall be billed in one-half-hour increments per use, rounded up, based on the amount of the time reserved.
 - 3. All fees will be collected up front, based on the amount of field time reserved, at the beginning of each season.
 - 4. If there are any hours paid for and not used, due to rainouts or other cancellations, said fees shall be refunded in a reasonable time following the end of the sports season.
 - 5. Borough Sponsored Recreation Leagues and Borough Schools shall be exempt from the lightening fee in Section J(1). Borough Recognized Youth Sport Organizations will be exempt from the fee in Section J(1) pursuant to the terms of the grant agreement.

K. Athletic field use fees:

- 1. When any sports team or league seeks to reserve the use of a Borough athletic field, it shall be charged a fee for the use as set forth below:
 - i. \$25 per two-hour increment for resident teams or Non-Profit organizations;
 - ii. \$50 per two-hour increment for non-resident or For-Profit organizations.
- 2. All fees will be collected up front, based on the amount of field time reserved, at the beginning of each season.
- 3. If there are any dates paid for and not used, due to rainouts or other cancellations, said fees shall be refunded in a reasonable time following the end of the sports season.

If any section, subsection, sentence, clause, phrase or portion of this ordinance is for any reason held to be invalid or unconstitutional by a court of competent jurisdiction, such portion shall be deemed a separate, distinct and independent provision, and such holding shall not affect the validity of the remaining portions hereof.

SECTION 4. This ordinance shall take effect after second reading and publication as required by law.
