ORDINANCE 2023-30

AN ORDINANCE OF THE BOROUGH OF SOUTH RIVER, COUNTY OF MIDDLESEX, STATE OF NEW JERSEY AMENDING THE BOROUGH CODE OF THE BOROUGH OF SOUTH RIVER, SO AS TO AMEND CHAPTER 155, ENTITLED "FEES"

BE IT ORDAINED by the Mayor and Borough Council of the Borough of South River, County of

Middlesex, and State of New Jersey, as follows:

SECTION 1. The Borough Code of the Borough of South River is hereby amended and supplemented so as to amend Chapter 155 entitled "Fees," so as to create a new section § 155-19.2,

which shall be entitled "Chapter 261 Redevelopment" and which shall read as follows:

§ 155-19.2 Redevelopment.

A. The fee for a Redeveloper application shall be \$5,000.00

B. Upon execution of a developer agreement, redevelopers will make a nonrefundable payment of 1% of the total estimated assessed value of the project, up to a maximum of \$100,000.

C. Escrow fee for professional review of redevelopment projects shall be as follows:

- 1. \$5,000.00 for projects with a total estimated project cost less of than \$3,000,000;
- 2. \$10,000.00 for projects with a total estimated project cost of greater than \$3,000,000 and less than \$10,000,000; and
- 3. \$15,000.00 for projects with a total estimated project cost of greater than \$10,000,000.

SECTION 2. All ordinances or parts of ordinances inconsistent herewith are hereby repealed.

SECTION 3. This ordinance shall take effect after second reading and publication as required by

law.
