A LOCAL LAW AMENDING SECTION 4-4 "RESIDENCY" OF THE VILLAGE CODE OF
THE VILLAGE OF SPRING VALLEY

Section 1. Legislative Intent

In July 2018 the Village Board resolved to re-establish the Village as its own assessing unit. In order to hire a competent Assessor, the Village Board believes it is in the best interests of the Village to pass a local law that will allow residents of Counties of Rockland, Westchester and Orange County be eligible for appointment to Village Assessor.

Section 2. Statutory authority.

This article is adopted pursuant to Municipal Home Rule Law § 10(1)(ii)(a)(1) that grants to local governments the authority to enact local laws regarding the qualifications of local officers.

Section 3. Supersession of State law.

This article shall supersede Village Law § 3-300 in its application to the office of Village Assessor in the Village of Spring Valley.

Section 4. Amendment of §4-4 of Spring Valley Village Code:

The offices of Assessor, Attorney, Clerk, Treasurer, Superintendent of Public Works, accounting firm and Building Inspector and all deputies may be held by parties residing outside the corporate limits of the village within the county. The office of Assessor may be held by parties residing outside the corporate limits of the village, but within the limits of the Counties of Rockland, Orange or Westchester.

Section 5. Effective Date

This local law shall be effective immediately upon filing with the Secretary of State.
