

ORDINANCE NO. 7957

AN ORDINANCE AMENDING SCHEDULE III, TABLE III-C TO PROHIBIT PARKING AT CERTAIN TIMES ON ALL STREETS IN MANORS AT ORCHARD GLEN SUBDIVISION, OF TITLE III, SECTION 365.040 OF THE MUNICIPAL CODE OF THE CITY OF ST. PETERS, MISSOURI

WHEREAS, the City of St. Peters adopted the Model Traffic Ordinance, Chapter 300, Revised Statutes of Missouri, as amended, as and for the Traffic Ordinance of the City with passage of Ordinance No. 496, as amended, and Title III Tables III-A, III-B, and III-C, list streets within the City limits that prohibit parking, standing, and stopping of vehicles at certain times on certain streets; and

WHEREAS, residents of the City living in Manors at Orchard Glen Subdivision and the Fort Zumwalt School District have requested that the City consider taking action to control certain traffic conditions due to student vehicles in Manors at Orchard Glen Subdivision; and

WHEREAS, the Board of Aldermen did, on March 11, 2010, implement Ordinance No. 5345, which prohibited parking on all streets in Manors at Orchard Glen Subdivision between the hours of 9:00am and 2:00pm, except on holidays and weekends; and

WHEREAS, the Fort Zumwalt East High School schedule has since changed, necessitating an amendment to Schedule III, Table III-C of the Municipal Code of the City of St. Peters, Missouri to prohibit on-street parking on all streets in Manors at Orchard Glen Subdivision from 9:00am to 3:00pm, except on weekends and holidays.

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF ALDERMEN OF THE CITY OF ST. PETERS, MISSOURI, AS FOLLOWS:

SECTION 1. Schedule III, Table III-C of Title III, Section 365.040, of the Municipal Code of the City of St. Peters, Missouri, is hereby amended to the following:

Berry Manor Circle, both sides of Berry Manor Circle: No parking shall be allowed between the hours of 9:00 A.M. and 3:00 P.M., except on weekends and holidays
Jessie Marie Lane, both sides of Jessie Marie Lane: No parking shall be allowed between the hours of 9:00 A.M. and 3:00 P.M., except on weekends and holidays

SECTION 2. In accordance with Title III of the Municipal Code of the City of St. Peters, Missouri, and when signs are erected giving notice thereof, no person shall park a vehicle on Berry Manor Circle or Jessie Marie Lane at certain times as follows:

Berry Manor Circle, both sides of Berry Manor Circle: No parking shall be allowed between the hours of 9:00 A.M. and 3:00 P.M., except on weekends and holidays

Jessie Marie Lane, both sides of Jessie Marie Lane: No parking shall be allowed between the hours of 9:00 A.M. and 3:00 P.M., except on weekends and holidays

SECTION 3. Savings Clause

Nothing contained herein shall in any manner be deemed or construed to alter, modify, supersede, supplant or otherwise nullify any other Ordinance of the City or the requirements thereof whether or not relating to or in any manner connected with the subject matter hereof, unless expressly set forth herein.


SECTION 4. Severability Clause


If any term, condition, or provision of this Ordinance shall, to any extent, be held to be invalid or unenforceable, the remainder hereof shall be valid in all other respects and continue to be effective and each and every remaining provision hereof shall be valid and shall be enforced to the fullest extent permitted by law, it being the intent of the Board of Aldermen that it would have enacted this Ordinance without the invalid or unenforceable provisions. In the event of a subsequent change in applicable law so that the provision which had been held invalid is no longer invalid, said provision shall thereupon return to full force and effect without further action by the City and shall thereafter be binding.

SECTION 5. The Ordinance shall be in full force and take effect from and after the date of its final passage and approval.
