#### Local Law No. 4 of the Year 2024

### A LOCAL LAW TO AMEND LOCAL LAW NO. 4 OF 2021

**Explanation:** This Amendment to Local Law No. 4 of 2021 shall be for the purpose of extending the sunset date of the Local Law from December 31, 2023 until December 31, 2025. The Amendment will extend the hunting opportunities afforded to twelve (12) and thirteen (13) year old individuals pursuant to Environmental Law § 11-0935 until December 31, 2025.

**Legislative Intent**: The Sullivan County Legislature, after consideration, declares that it is best interest of the citizens of Sullivan County to amend Local Law No. 4 of 2021 by extending its sunset date until December 31, 2025. Said changes to Local Law No. 4 of 2021 are detailed below.

#### Amendments:

- (1) Delete the following language in line six (6) of Section 1; "2023" and insert the following language in its place; "December 31, 2025".
- (2) Delete the following language in line three (3) of Section 2; "2023" and insert the following language in its place; "December 31, 2025".

All other language remains unchanged and in full force and effect.

**Effective**: This Local Law shall become effective as of the date of filing with the Secretary of State.
