ORDINANCE NO. 33-2020 AMENDING SECTION 36-11.2 OF DIVISION 1 OF ARTICLE II OF CHAPTER 36, ENTITLED “TRAFFIC,” OF THE TOWNSHIP CODE TO DELETE A RESTRICTED ON-STREET PARKING SPACE FOR HANDICAPPED ALONG A PORTION OF CIRCLE DRIVEWAY BE IT RESOLVED BY THE TOWNSHIP COUNCIL OF THE TOWNSHIP OF TEANECK THAT ORDINANCE #33-2020 PASS UPON SECOND AND FINAL READING AND THAT THE TOWNSHIP CLERK IS HEREBY AUTHORIZED AND DIRECTED TO ADVERTISE THE SAME ACCORDING TO LAW AND TO PROVIDE THE APPROPRIATE NOTICES IN ACCORDANCE WITH LAW.

BE IT ORDAINED by the Township Council of the Township of Teaneck, Bergen County, New Jersey, as follows:

SECTION 1. Section 36-11.2 “Establishment of restricted on-street parking spaces for handicapped” of Division 1 “Generally” of Article II “Parking” of Chapter 36 entitled “Traffic,” of the Code of the Township of Teaneck is hereby amended to delete therefrom the following streets or portions thereof:

Circle Driveway: North side, from a point approximately 300 feet east of the easterly curbline of Arlington Avenue and extending 32 feet easterly therefrom.

SECTION 2. Inconsistency. All ordinances or parts of ordinances contrary to or inconsistent with the provisions of this ordinance are hereby superseded to the extent of such inconsistency.

SECTION 3. Severability. If any section, sentence, clause or other portion of this ordinance, or the application thereof to any person or circumstance, shall be adjudged by a court of competent jurisdiction to be invalid or unconstitutional, such judgment shall not affect, impair or repeal the remainder of this ordinance.

SECTION 4. Effective Date. This ordinance shall take effect twenty days after passage and publication, except as otherwise provided by law.
