SECTION 1.

Overriding Tax Levy Limit for 2024. For fiscal year 2024 the County of Tompkins is hereby authorized to override the real property tax levy limit established by Chapter 97 of the Laws of 2011 of the State of New York (Section 3-c of the General Municipal Law) and may adopt a budget requiring a tax levy that is greater than such tax levy limit.

SECTION 2.

Effective Date. This Local Law shall become effective immediately upon filing with the Secretary of State.
