BE IT ORDAINED, By the City Council of the City of Trenton that Chapter 14, Subsection 3.17 of the Code of the City of Trenton is hereby amended by removing from Schedule XXI, "Bus Stops," the following location:

Along Martin Luther King Jr. Boulevard, southbound on the westerly side thereof at:

Sweets Avenue - (Near Side)

Beginning at the northerly curb line of Sweets Avenue and extending 105 feet northerly therefrom.

BE IT FURTHER ORDAINED, By the City Council of the City of Trenton that Chapter 14, Subsection 3.17 of the Code of the City of Trenton is hereby amended and supplemented by adding to Schedule XXI, "Bus Stops," the following location:

Along Martin Luther King Jr. Boulevard, southbound on the westerly side thereof at:

Fountain Avenue - (Near Side)
Beginning at the northerly curb line of Fountain Avenue and extending 105 feet northerly therefrom.
