BE IT ORDAINED, By the City Council of the City of Trenton that Chapter 14, Subsection 3.17 of the Code of the City of Trenton is hereby amended by removing from Schedule XXI, "Bus Stops," the following location:

Along Martin Luther King Jr. Boulevard, northbound on the easterly side thereof at:

Sweets Avenue - (Far Side)

Beginning at the northerly curb line of Sweets Avenue and extending 105 feet northerly therefrom.

Along Roebling Avenue, westbound on the northerly side thereof at:

Franklin Street - (Far Side)

Beginning at the westerly curb line of Franklin Street and extending 100 feet westerly therefrom.

BE IT FURTHER ORDAINED, By the City Council of the City of Trenton that Chapter 14, Subsection 3.17 of the Code of the City of Trenton is hereby amended and supplemented by adding to Schedule XXI, "Bus Stops," the following location:

<u>Along Martin Luther King Jr. Boulevard, northbound on the easterly side thereof</u> <u>at:</u>

Sanford Street - (Near Side) Beginning at the northerly curb line of Sanford Street and extending 105 feet southerly therefrom.
