

RESOLUTION NO. R-31-2023

A RESOLUTION OF THE BOARD OF SUPERVISORS OF THE TOWNSHIP OF UNITY, COUNTY OF WESTMORELAND, COMMONWEALTH OF PENNSYLVANIA ESTABLISHING A ROAD CLOSURE SCHEDULE FOR THE DECEMBER 2, 2023, ST. BARTHOLOMEW CHURCH 5K RACE FUNDRAISER

WHEREAS, the St. Bartholomew Catholic Church (hereafter the "Church") has requested permission to close a certain Township Road to ensure public safety during a 5K Race Fundraiser on Saturday December 2, 2023, from 11:00 a.m. to 12:30 p.m.; and

WHEREAS, the Church has also requested permission from the Board of Supervisors to utilize the Crabtree Volunteer Fire Department to assist the Church by providing emergency services including, but not limited to, maintaining road closures and traffic control measures, throughout the course of the event; and

WHEREAS, the Board of Supervisors adopts this Resolution to approve the aforesaid requests.

NOW, THEREFORE, WITH THE FOREGOING RECITALS BEING INCORPORATED HEREIN BY REFERENCE THERETO, THE BOARD OF SUPERVISORS HEREBY RESOLVE AS FOLLOWS:

1. That Cemetery Road (TR 852) shall be subject to closure from State Route 119 to Luxor Road, on Saturday December 2, 2023, from 11:00 a.m. to 12:30 p.m. to accommodate the Church's 5K Race Fundraiser;

2. The Church shall be responsible for traffic and crowd control during the aforesaid 5K Race Fundraiser and may utilize the services of the Crabtree Volunteer Fire Department to provide same.


3. The Church shall carry liability insurance providing coverage for all bodily injury and property loss claims arising from or which could arise from such road closures with limits of not less than \$500,000.00 per occurrence. The Township shall be named as an additional insured on such policy and the Church shall provide with an ACORD

Certificate of Insurance as evidence of same not later than Noon on Tuesday, November 21, 2023.

THIS RESOLUTION IS DULY APPROVED AND ADOPTED BY THE BOARD OF SUPERVISORS OF THE TOWNSHIP OF UNITY AT A DULY ADVERTISED PUBLIC MEETING HELD THE 9th DAY OF NOVEMBER, 2023 AND SHALL BE EFFECTIVE IMMEDIATELY.
