**ORDINANCE # 2021-22**

**ORDINANCE AMENDING SALARY ORDINANCE FOR MUNICIPAL EMPLOYEES**

**WHEREAS**, pursuant to N.J.S.A. 40A:9-165, the governing body of a municipality shall fix and determine the salaries, wages or compensation to be paid to its officers and employees by way of ordinance; and

**WHEREAS**, the City of Union City (the "City") is a municipality as defined by Title 40 of the New Jersey Statutes; and

**WHEREAS**, from time to time the City updates the salaries, wages and compensation of its officers and employees by ordinance; and

**WHEREAS**, the City now seeks to again update the salaries, wages and compensation of its officers and employees, and same will be on file in the office of the City Clerk and available for examination during normal office hours.

**NOW, THEREFORE, BE IT ORDAINED**, by the Board of Commissioners of the City of Union City, County of Hudson, State of New Jersey that the City's Salary Ordinance is hereby amended and revised as set forth in the attached schedule and will be available for examination during normal office hours in the Office of the City Clerk.

**SECTION ONE:**

**Severability.** If any term or provision of this Ordinance is held to be illegal, invalid, or unenforceable by a court of competent jurisdiction, in whole or in part, such determination shall not affect the validity of the remaining terms and provisions of this Ordinance.

**SECTION TWO:**

**Repealer.** To the extent that any provision of the Code of the City of Union City is found to conflict with this Ordinance, in whole or in part, this Ordinance shall control.

**SECTION THREE:**

In order to avoid accidental repeal of existing provisions, the City Clerk and the Corporation Counsel are hereby authorized to change any chapter numbers, article numbers and/or section numbers in the event that the codification of this Ordinance reveals that there is a conflict between those numbers and the existing Code.

**SECTION FOUR:**

This Ordinance shall take effect upon passage and publication as required by law.


