A RESOLUTION OF THE BOARD OF DIRECTORS OF THE VALLEY FORGE SEWER AUTHORITY AMENDING THE CODE OF RULES AND REGULATIONS OF THE VALLEY FORGE SEWER AUTHORITY BY AMENDING CHAPTER 110 SEWER USE, APPENDIX A RULES AND REGULATIONS GOVERNING ACCEPTANCE OF INDUSTRIAL WASTE, TRUCKED INDUSTRIAL WASTE, HOLDING TANK WASTE AND SEPTAGE; CHAPTER 110 SEWER USE ARTICLE V -- PRETREATMENT FEES.

WHEREAS, the Board of Directors of the Authority finds it desirable, necessary and proper, and in the best interest of the Authority, to amend the fee amounts in ARTICLE V - Pretreatment Fees.

NOW, THEREFORE, the Board of Directors of the Valley Forge Sewer Authority, this 13th day of November 2023 hereby resolves as follows:

<u>Section 1.</u> The Code of Rules and Regulations of the Valley Forge Sewer (the "Code"), ARTICLE V, Pretreatment Fees, Section §110-45 is amended as follows:

A. (1) For each sampling and analysis event by VFSA personnel and laboratory.

(a) Per composite sample: \$350.00

(b) Per grab sample: \$250.00

B. (1) Initial Permitting

(a) Categorical Industries: \$13,300.00

- (b) Non-categorical large-flow industries (industries with average daily flows greater than 10,000 gallons): \$9,100.00
- (c) Non-categorical medium-flow industries (industries with average daily Flows of 1,000 to 10,000 gallons): \$6,600.00
- (d) Non-categorical small-flow industries (industries with average daily flows less than 1,000 gallons): \$5,500.00

(e) Commercial user: \$800.00

(2) Re-permitting

(a) Categorical industries:

\$3,700.00

- (b) Non-categorical large-flow industries (industries with average daily flow greater than 10,000 gallons): \$2,600.00
- (c) Non-categorical medium-flow industries (industries with average daily flows of 1,000 to 10,000 gallons): \$1,700.00
- (d) Non-categorical small-flow industries (industries with average daily flows less than 1,000 gallons): \$1,400.00

E. Administrative fee. For the processing of each invoice, statement or bill for services, including but not limited to invoices, statement or bills for sampling events, permits, repermits, licenses and surcharges: the amount of \$65 per invoice.

Section 2: The fees outlined in this resolution shall take effect on January 1, 2024.
