## AN ORDINANCE OF THE CITY OF VENTNOR, COUNTY OF ATLANTIC, STATE OF NEW JERSEY AMENDING AND SUPPLEMENTING CHAPTER 214 VEHICLES AND TRAFFIC ARTICLE XI SCHEDULES CHAPTER 40 SCHEDULE XII :LOADING ZONES

**WHEREAS,** The Mayor and Board of Commissioners of the City of Ventnor City, New Jersey find that the amending certain aspects of existing ordinances is an important matter; and

WHEREAS, Chapter 214 Vehicles and Traffic shall be amended as set forth below.

## § 214-40 Schedule XII: Loading Zones.

In accordance with the provisions of § **214-17**, the following described locations are hereby designated as loading zones:

Name of Street	Side Hours	Location
Atlantic Avenue	South 8:00 a.m. to 7:00 p.m., daily	From a point 25 feet east of the east curbline of Weymouth Avenue to a point 56 feet east thereof
Little Rock Avenue	East 8:00 a.m. to 7:00 p.m., except Sunda	From a point 25 feet north of the northerly aycurbline of Ventnor Avenue to a point 50 feet north thereof
Little Rock Avenue	West 7:00 a.m. to 9:00 p.m., except Sunda	From a point 25 feet south of the southerly aycurbline of Ventnor Avenue to a point 50 feet south thereof
Victoria Avenue	East 8:00 a.m. to 9:00 p.m., daily	From a point 25 feet north of the northerly curbline of Ventnor Avenue to a point 50 feet north thereof
Washington Avenue	West 8:00 a.m. to 7:00 p.m., except Sunda	From a point 25 feet north of the northerly aycurbline of Ventnor Avenue to a point 50 feet north thereof
Wyoming Avenue	East 8:00 a.m. to 4:00 p.m., daily	From a point 25 feet north of the northerly curbline of Ventnor Avenue to a point 50 feet north thereof

SECTION II. All ordinances or parts of ordinances inconsistent herewith are hereby repealed to the extent of such inconsistency.

SECTION III. Should any section, subsection, paragraph, clause, sentence or other portion of this Ordinance be adjudged by a Court of competent jurisdiction to be invalid, such judgment shall not affect, impair or invalidate the remainder of this Ordinance.

SECTION IV. This Ordinance shall take effect immediately upon final passage, approval, and publication as required by law.
