ORDINANCE AMENDING A CHAPTER OF THE CODE OF THE TOWNSHIP OF WASHINGTON
CHAPTER 260 SECTION 14 - VEHICLES AND TRAFFIC - TO RESTRICT STOPPING, STANDING OR
PARKING ON CERTAIN SECTIONS OF PITMAN-DOWNER ROAD (COUNTY ROUTE 658)

BE IT ORDAINED by the Township Council of Township of Washington, County of Gloucester, State of New Jersey that the following changes to Chapter 260-14 of the Township Code is hereby adopted.

ARTICLE II Stopping, Standing, and Parking

§260-14 Parking prohibited at all times on certain streets

Section A: No person shall stop or stand or park a vehicle at any time, upon the following streets or parts thereof listed below:

Name of Street	Side	Location
Pitman-Downer Road (County Route 658)	South	From Intersection of Pitman-Downer Road & Glassboro Cross-Keys Road Drive to a point 1290 feet west.

Section B: Regulatory signs conforming to the current *Manual on Uniform Traffic Control devices for Streets and Highways, (current edition)* shall be erected and maintained at the above-designated location.

Section C: Any ordinances or parts of ordinances in conflict with any of the provisions of this ordinance are hereby repealed.

SECTION 2. Except as set forth in Section 1, the balance of the Code of the Township of Washington shall not be affected by this Ordinance.

SECTION 3. All Ordinances contrary to the provisions of this Ordinance are hereby repealed to the extent that they are inconsistent herewith.


SECTION 4. If the provisions of any section, subsection, paragraph, subdivision, or clause of this Ordinance shall be judged invalid by a court of competent jurisdiction, such order of judgment shall not affect or invalidate the remainder of any section, subsection, paragraph, subdivision, or clause of this Ordinance.

SECTION 5. This Ordinance shall take effect thirty (30) days after final passage by Council or twenty (20) days after approval by the Mayor, whichever comes first.
