ORDINANCE PROVIDING FOR THE AUTHORIZATION OF

VARIOUS ROAD IMPROVEMENTS IN AND BY THE TOWNSHIP OF WASHINGTON, IN THE COUNTY OF

MORRIS, NEW JERSEY, AND APPROPRIATING \$137,000.00 THEREFOR FROM THE CAPITAL RESERVE FUND OF THE

TOWNSHIP

BE IT ORDAINED BY TOWNSHIP COMMITTEE OF THE TOWNSHIP OF

WASHINGTON, IN THE COUNTY OF MORRIS, NEW JERSEY, AS FOLLOWS:

Section 1. The improvement described in Section 2 of this ordinance is hereby

authorized as a general improvement to be made or acquired by the Township of Washington, in the County

of Morris, New Jersey, and there is hereby appropriated therefor the sum of \$137,000.00, from moneys

available in the Capital Reserve Fund of the Township.

Section 2. The improvements hereby authorized and the purposes for the financing

of which the appropriation is made as provided in Section 1 of this ordinance is the authorization of various

road improvements, as set forth in the bid specifications for same.

Section 3. The capital budget or temporary capital budget of the Township is hereby

amended to conform with the provisions of this ordinance to the extent of any inconsistency herewith and

the resolutions promulgated by the Local Finance Board showing all detail of the amended capital budget

or temporary capital budget and capital program as approved by the Director, Division of Local

Government Services, are on file with the Township Clerk and are available for public inspection.

Section 4. This ordinance shall take effect after publication after final passage as

provided by law.
