ORDINANCE NO. 1905 BILL NO. 20 OF 2017

AN ORDINANCE OF THE COUNCIL OF THE CITY OF WASHINGTON, WASHINGTON COUNTY, PENNSYLVANIA, PROVIDING FOR THE PROHIBITION OF LEFT TURNS FOR TRAFFIC TRAVELING IN A WESTERLY DIRECTION ON PROSPECT STREET WITH ITS INTERSECTION OF ELM STREET.

WHEREAS, the Council of the City of Washington is desirous of protecting the health and safety of its residents by controlling the flow of traffic for vehicles traveling in a westerly direction on Prospect Street at the intersection with Elm Street in the City of Washington, County of Washington, Commonwealth of Pennsylvania.

NOW, THEREFORE, BE IT ORDAINED AND ENACTED by the Council of the City of Washington and it is hereby ordained and enacted as follows:

Section 1. From and after the date of this Ordinance all vehicles traveling in a westerly direction on Prospect Street in the City of Washington, County of Washington, Commonwealth of Pennsylvania shall be prohibited from making a left turn from Prospect Street onto Elm Street at the intersection of Prospect Street and Elm Street in the City of Washington, County of Washington, Commonwealth of Pennsylvania. All vehicles traveling in a westbound direction on Prospect Street shall only be permitted to make a right turn from Prospect Street onto Elm Street at the intersection of Prospect Street and Elm Street in the City of Washington, County of Washington, Commonwealth of Pennsylvania.

Section 2. Any Ordinance or part of an Ordinance in conflict herewith is hereby repealed.

Section 3. If any sentence, clause, section, or part of this Ordinance is for any reason found to be unconstitutional, illegal or invalid, such unconstitutionality, illegality or invalidity shall not affect or impair any of the remaining provisions, sentences, clauses, sections or parts of this Ordinance. It is hereby declared as the intent of the Council of the City of Washington that this Ordinance would have been adopted had such unconstitutional, illegal or invalid sentence, clause, section or part thereof not been included herein.

WHEREAS, City Council for the City of Washington deems that it is in the best interest of the citizens and residents of the City of Washington to approve Ordinance No. 1905 BILL No. 20.


ORDAINED AND ENACTED this 21st day of December, 2017, by the Council of the City of Washington in lawful session duly assembled.

This Ordinance shall become effective upon **FINAL PASSAGE** and shall be applicable for the year 2017.
