*WHEREAS*, City Council for the City of Washington is desirous of amending Ordinance 1478 Chapter 282- Shade Tree Commission.

*WHEREAS*, City Council for the City of Washington deems that it is in the best interest of the citizens and residents of the City of Washington to amend certain provisions of Ordinance 1478 Sections 282.3, 282.4, 282.5, 282.6.

ORDINANCE NO. 1910 Bm No. 5

AN ORDINANCE OF THE COUNCIL OF THE CITY OF WASHINGTON, WASHINGTON COUNTY, PENNSYLVANIA, AMENDING CHAPTER 282 – SHADE TREES, OF THE CONSOLIDATED STATUTES OF THE CITY OF WASHINGTON, DELETING IN THEIR ENTIRETY SECTIONS 282.3, 282.4, 282.5, 282.6; DELETING THE TERM SHADE TREE COMMISSION AND SUBSTITUTING CITY COUNCIL IN ALL OTHER SECTIONS OF CHAPTER 282.

WHEREAS, on June 27, 1994 the Mayor and Council of the City of Washington adopted Ordinance No. 1478 (Chapter 25 of the 1986 Code of Ordinances), creating and establishing a Shade Tree Commission to study, investigate, counsel, develop, update annually and administer a written plan for the care, preservation, pruning, planting, re-planting, maintenance, protection, removal or disposition of trees and shrubs in parks, along streets, and in other public areas in the City of Washington; and

WHEREAS, the Mayor and Council of the City of Washington are desirous of disbanding, formally, the Shade Tree Commission.

NOW, THEREFORE, BE IT ORDAINED AND ENACTED by the Mayor and Council of the City of Washington and it is hereby ordained and enacted as follows:

**Section 1.** Section 282.3, 282.4, 282.5 and 282.6 of Chapter 282 of the Codified Ordinances of the City of Washington are hereby deleted in their entirety.

**Section 2.** The current terms Shade Tree Commission, City Commission and Commission contained in Sections 282.7, 282.8, 282.9, 282.10, 282.11, 282.12, 282.13, 282.14,

282.15, 282.16, 282.17, 282.18, 282.19, 282.20, 282.21 and 282.22 shall be deleted and the term "Mayor and Council and City Council" shall be substituted in their place.

**Section 3.** All other terms and conditions of Chapter 282 shall remain if full force and effect.


**Section 4.** Any Ordinance or part of an Ordinance in conflict herewith is hereby repealed.

**Section 5.** If any sentence, clause, section, or part of this Ordinance is for any reason found to be unconstitutional, illegal or invalid, such unconstitutionality, illegality or invalidity shall not affect or impair any of the remaining provisions, sentences, clauses, sections or parts of this Ordinance. It is hereby declared as the intent of the Council of the City of Washington that this Ordinance would have been adopted had such unconstitutional, illegal or invalid sentence, clause, section or part thereof not been included herein.
