ORDINANCE NO. 2023-08

AN ORDINANCE OF THE TOWNSHIP OF WASHINGTON, IN THE COUNTY OF BURLINGTON, STATE OF NEW JERSEY AMENDING CHAPTER 155 OF THE CODE OF THE TOWNSHIP OF WASHINGTON TO ADDRESS OFF SEASON VISITATION, OCCUPANCY OF CAMPING UNITS, AND THE USE OF CAMPER PERSON PROPERTY WITHIN THE TOWNSHIP

WHEREAS, the Committee of the Township of Washington (the "Township") believes that it is in the best interest of the health, safety and general welfare of its residents to provide guidelines and time periods as to when camping unit owners may visit and occupy their camping units during the off season hours which are defined as November 1 to March 31 of any given year; and

WHEREAS, the Township Committee further believes that regulations should be established prohibiting the use of golf carts and other all-terrain vehicles on Township and County roadways within the Township.

NOW, THEREFORE, BE IT HEREBY ORDAINED by the Committee of the Township of Washington, in the County of Burlington, State of New Jersey, that:

SECTION 1. Section 155-6 entitled "Use of campground unit as residence restricted" is hereby amended to read as follows:

No person shall occupy, as owner or occupant, or shall rent or make available to another for occupancy, any campground unit for residential purposes.

This prohibition shall include any temporary, seasonal or year-round residential occupancy by any owner, manager, caretaker, or employee of the campground. Notwithstanding anything aforegoing, however, each campground within the Township may designate one campsite, which must be registered with the Code Enforcement Officer, which may be occupied on a full-time basis by one caretaker. However, this provision shall not be deemed to create a legal residence or family dwelling within a campground and is solely for purposes of allowing one full-time caretaker to care for the campground.

For the calendar year 2021 only, the camping season shall run for the period from April 1 to November 15. Commencing on April 1, 2022, and in every year thereafter, the camping season shall run for the period from April 1 to November 1. From November 1 to April 1, the occupancy of any one camping unit, other than the caretaker's unit, shall prohibited.

For purposes of this Chapter, no person may occupy any campground unit during the period from November 1 to March 31 (the "Off Season") of any given year unless that person is

visiting the campground for the sole and exclusive purpose of inspecting and ensuring the safety of the campground unit on any given individual day. In the event that any person does visit the campground during the Off Season for the sole and exclusive person of inspecting and ensuring the safety of any campground unit, said person(s) shall vacate the campground no later than 5:00 p.m. on that day of visitation.

SECTION 2. Section 155-20 entitled "Camping vehicles and trailers" is hereby amended to read as follows:

- A. Camping vehicles occupying either a campsite or storage area shall be registered, over-the-road motor vehicles and trailers and shall be licensed in New Jersey or the state of residence of the unit owner. For purposes of this section, "camping vehicle" shall include, in addition to the definitions set forth in §§ 155-1 and 155-2, vehicles which may be legally driven or towed by a passenger motor vehicle on a highway and are registered by the State Department of Motor Vehicles as a recreational vehicle or identified permanently as "travel trailer" or "recreational vehicle" by the manufacturer.
- B. Further, camping vehicles shall remain equipped with axles and wheels and may be stabilized temporarily with jacks, stands or other devices which are normal camping or motor vehicle equipment. The construction of permanent foundations, columns, pillars and similar structures shall be prohibited.
- C. It shall be unlawful for any occupant at any campground within the Township to use or operate an unregistered golf cart or all terrain vehicle(s) on any Township or County of Burlington public road at any time. A violation of this Section 155-20C. shall carry a fine of not less than \$200 nor more than \$1,000 per occurrence.
- D. Every campground owner within the Township shall clearly and legibly display a highlighted copy of Section 155-20C. on its website and post the same in a conspicuous location within the campground so that all campground occupants are aware of the provisions of said section.

SECTION 3. If any section, paragraph, subsection, clause, or provision of this Amendment shall be adjudged by the courts to be invalid, such adjudication shall apply only to the section, paragraph, subsection, clause, or provisions so adjudicated, and the remainder of the Ordinance shall be deemed valid and effective.

SECTION 4. If any ordinances or parts thereof are in conflict with the provisions of this Ordinance those provisions shall be repealed to the extent of such conflict.

SECTION 5. This Ordinance shall take effect upon passage and publication in accordance within applicable law.
