ORDINANCE NO. 24-5

**An Ordinance to Amend Chapter 375 Vehicles and Traffic Article VIII A Employee Parking**

**BE IT ORDAINED** by the Mayor and Council of the Borough of Westwood that Chapter 375 Article VIII A entitled Employee Parking, is hereby amended as follows (deleted sections are noted by strikethroughs, new sections underlined and bold):

**Section 1.** Amend § 375-46.1 **Designated employee parking zones.**

The following streets or parts of streets, and metered spaces within the municipal parking lots, are designated as employee parking zones. No person shall park a vehicle between the hours of 6:00 a.m. and 6:00 p.m. Monday through Saturday unless the vehicle has displayed from its rear view mirror a valid and current employee parking hang tag.

<b>Name of Street</b>	<b>Side</b>	<b>Location</b>
Center Avenue (North Lot)	West	In Municipal Lot B, as described in Chapter <b>237</b> , Article <b>I</b> , § <b>237-1</b> , the last four spaces at the north end of the eastern row, the last three spaces on each side of the center island at the north end of the center row, and the last four spaces at the north end of the western row designated as employee parking and requiring a valid and current hang tag
<u>Center Avenue (South Lot)</u>	<u>South</u>	<u>In Municipal Lot A, as describe in Chapter 237, Article I, § 237-1, the southernmost row, all 12 spaces, designated as employee parking and requiring a valid and current hang tag</u>
Fairview Avenue	East	From Bergen Street to Jefferson Avenue, designated as employee parking and requiring a valid and current hang tag
Fairview Avenue	West	From Bergen Street to Jefferson Avenue designated as employee parking and requiring a valid and current hang tag
Fourth Avenue		[Added 4-17-2018 by Ord. No. 18-8; repealed 11-12-2019 by Ord. No. 19-20]
Madison Avenue	East	From Irvington Street, north for a distance of 360 feet, designated as employee parking and requiring a valid and current hang tag

Municipal Lot C  
(Fairview Avenue Lot)

West

In Municipal Lot C, as described in Chapter 237, Article I, § 237-1, the westernmost row, all 13 spaces, designated as employee parking and requiring a valid and current hang tag

Washington Avenue

North

From a point 150 feet east of the easterly curblineline of Irvington Street, east for a distance of 165 feet

Section 2. If any section, subsection, paragraph, sentence or any other part of this ordinance is adjudged unconstitutional or invalid, such judgment shall not affect, impair or invalidate the remainder of this ordinance.

Section 3. All ordinances or parts of ordinances which are inconsistent with the provisions of this ordinance are hereby repealed to the extent of such inconsistency.

Section 4. If any section, subsection, part, clause or phrase of this Ordinance shall be declared invalid by judgment of any court of competent jurisdiction, such section, subsection, part, clause or phrase shall be deemed to be severable from the remainder of this Ordinance.


Section 5. This Ordinance shall take effect immediately upon final passage and publication as required by law.


