§36-1. Compliance required.

No camper, travel trailer, motor home or recreational vehicle may be used as a living facility in the Village of West Carthage except in accordance with this chapter.

§36-2. Permit required; location.

A. Any person wishing to use a camper, travel trailer, motor home or recreational vehicle as a living facility within the Village of West Carthage must first obtain a permit from the Village Code Enforcement Officer to do so. Such permit application must demonstrate:

(1) That there will be an adequate potable and sanitary water supply;

(2) That there will be an adequate self-contained septic holding tank for the actual use and demand and that such a tank will be emptied at a commercial facility specifically designed for such discharge.

(3) That the camper, travel trailer, motor home or recreational vehicle, as the case may be, is properly licensed and registered as required by law.

(4) That the camper, travel trailer, motor home or recreational vehicle, as the case may be, is properly connected to electrical service if required and such connection cannot be powered by a generator.

B. All campers, travel trailers, motor homes or recreational vehicles used pursuant to this chapter must be located on a lot owned by the applicant and outside of any Village right-of-way such as a street or sidewalk.

C. In no event shall a camper, travel trailer, motor home or recreational vehicle be utilized as or considered to be a permanent dwelling.

#### §36-3. Term of permit.

No permit shall be issued pursuant to this chapter for a period of longer than 14 consecutive days. Such permits may be issued more than once per year for any single parcel, provided that there shall be no more than one active permit per parcel at any time. Permits may be renewed at the discretion of the Village Code Enforcement Officer.

#### §36-4. Fees

The Village Board of Trustees may establish a fee for such permit from time to time by resolution.

#### §36-5. Penalties for offenses.

Any person who shall violate any of the provisions of this chapter shall, upon conviction, be guilty of a violation. Upon a finding that a violation has occured, the court may impose a fine not to exceed \$250 for each every violation. Each day a violation continues shall be considered a separate violation. The village may also consider whether to seek injunctive relief in a court of competent jurisdiction. Such relief shall not be precluded by the fact that fines have also been sought in local court.
