Refuse Disposal §48-1. Definitions: As used in this chapter, the following terms shall have the meanings indicated: Yard waste consists of vegetative or organic material produced from the care and maintenance of landscaped areas, gardens and lawns. This includes weeds, leaves, grass clippings, dead flowers and plants, brush, pruned branches and stems, dirt, roots, wood shavings, and Christmas trees. Sand spread during the winter season shall also be collected provided it has been placed in piles at the curb. Trash, refuse, rubbish and/or garbage includes but is not limited to food, dead animals, animal feces, furniture, appliances, or anything made from wood, metal, glass, or cloth, construction and demolition waste, rocks, paints, chemicals; anything that is not yard waste as described above.

#### §48-2. Yard Waste Collection

Yard waste may be placed at the curb, but not in the street, from April 1st to November 1st of each year for collection. Yard waste may be placed in reusable cans or paper bags. No plastic bags of yard waste shall be collected. The collection shall take place as needed and is weather dependent.

#### §48-3. Trees

No whole trees, sections of trees or branches larger than six inches (6") in diameter shall be collected except under special circumstances, such as storm damage, as determined by the village Board of Trustees.

### §48-4. Prohibited items

No item or items, other than garbage cans placed for weekly pickup by private haulers and yard waste, shall be placed between the street and the sidewalk or in the village right of way.

## §48-5. Enforcement

Any prohibited items or improperly placed yard waste, as determined by the Code Enforcement Officer, law enforcement officer or the Supervisor of Public Works, shall be immediately removed by the owner or occupant of the property upon written notification from the Code Enforcement Officer or upon verbal notification due to a serious violation or threat to the health, well-being and safety of the residents of the Village of West Carthage and passersby. In the event that the Village Board of the Village of West Carthage determines it is necessary that the Village perform corrective work on the alleged violator's property, all costs and expenses associated with such work shall be considered a special assessment against the property and may be charged to the landowner on the next succeeding tax bill of the Village of West Carthage.
