**ORDINANCE OF THE TOWNSHIP OF WEST ORANGE, IN  
THE COUNTY OF ESSEX, STATE OF NEW JERSEY (THE  
“TOWNSHIP”) PROVIDING FOR A SPECIAL EMERGENCY  
APPROPRIATION IN AN AMOUNT NOT TO EXCEED  
\$2,500,000 TO FUND THE PREPARATION AND  
EXECUTION OF A COMPLETE PROGRAM OF  
REVALUATION OF REAL PROPERTY IN THE TOWNSHIP**

**WHEREAS**, N.J.S.A. 40A:4-53(b) provides that a local unit, such as the Township of West Orange, in the County of Essex, State of New Jersey (the “Township”), may adopt an ordinance authorizing a special emergency appropriation for the preparation and execution of a complete program of revaluation of real property for the use of the local assessor, or of any program to update and make current any previous revaluation program when such is ordered by the county board of taxation; and

**WHEREAS**, the Essex County Board of Taxation has ordered the Township to implement a municipal wide and complete program of revaluation on all real property of the Township for use of the local assessor (the “Revaluation Program”); and

**WHEREAS**, pursuant to N.J.S.A. 40A:4-53(b), the Township desires to authorize a special emergency appropriation in the amount of not to exceed \$2,500,000 to fund the cost of the preparation and execution of the Revaluation Program.

**BE IT ORDAINED AND ENACTED BY THE TOWNSHIP COUNCIL OF THE TOWNSHIP OF WEST ORANGE, IN THE COUNTY OF ESSEX, STATE OF NEW JERSEY (not less than the majority of all members thereof affirmatively concurring) AS FOLLOWS:**

**SECTION 1.** Pursuant to N.J.S.A. 40A:4-53(b), the amount of not to exceed \$2,500,000 (a) is hereby appropriated to fund the cost of the preparation and execution of a complete program of revaluation of real property for the use of the local assessor, or of any program to update and make current any previous revaluation program as ordered by the Essex County Board of Taxation, and (b) shall be deemed a special emergency appropriation as defined and provided for in N.J.S. 40A:4-53. \$2,500,000

**SECTION 2.** To finance the appropriation authorized hereunder, and described in Section 1 hereof, special emergency notes of the Township (the “Notes”) shall be authorized by a resolution of the Township Council of the Township to be adopted in accordance with the provisions of N.J.S.A. 40A:4-55 or such appropriation may be financed from surplus funds available to the Township.

**SECTION 3.** A certified copy of this ordinance as finally adopted shall be filed with the Director of the Division of Local Government Services, in the New Jersey Department of Community Affairs.

**SECTION 4.** This ordinance shall take effect twenty (20) days after final adoption and approval by the Mayor.
