AN ORDINANCE AMENDING CHAPTER 5, SECTION 9.2 OF THE REVISED GENERAL ORDINANCES OF THE TOWNSHIP OF WEST ORANGE (FOOD AND BEVERAGE VENDING MACHINES-PERMIT AND LICENSE FEES)

BE IT ORDAINED BY THE MUNICIPAL COUNCIL OF THE TOWNSHIP OF

WEST ORANGE, NEW JERSEY that Chapter 5, Section 9.2 of the Revised General

Ordinances of the Township of West Orange be and are hereby amended as follows:

I. <u>PURPOSE</u>

The purpose of this ordinance is to modify the fines set forth in Chapter 5, Section 9.2 of the Revised General Ordinances of the Township of West Orange to be amendable by Resolution such that it is amendable in the future by approval of the Township Council, a necessity in an everchanging socioeconomic climate.

II. <u>CHAPTER 5, SECTION 9.2 SHALL BE AND HEREBY IS AMENDED AND</u> <u>SUPPLEMENTED TO INCORPORATE THE FOLLOWING:</u>

§5-9.2 BE AND HEREBY AMENDED AS FOLLOWS:

• The portion entitled "Permit and License Fees" which specifies the fee to be paid in accordance with operating a food and beverage machine within the Township of West Orange shall be repealed and replaced by the following language:

The annual fee for a permit or license under this section, which fee is to be collected by the Department of Health and Welfare, shall be as follows:prescribed by Resolution. **a.** Permit Fee: \$40 per year. **b.** License Fee: \$30 for one machine per year and \$15 for each additional machine per year with a maximum of \$250 for any number of machines.

III. <u>REPEAL OF CONFLICTING ORDINANCES</u>

Any Ordinances of the Township which are in conflict with this Ordinance are hereby repealed to the extent of such conflict.

IV. <u>SEVERABILITY</u>

If any part of this Ordinance shall be deemed invalid, such parts shall be severed and the invalidity thereof shall not affect the remaining parts of this Ordinance.

V. <u>EFFECTIVE DATE</u>

This Ordinance shall take effect upon final passage and publication in accordance with the law.
