

ORDINANCE NO. 23-1520

ORDINANCE AMENDING CHAPTER 97-119(B) (1) MEAL EXPENSE, VILLAGE OF WESTVILLE, VERMILION COUNTY, ILLINOIS, ORDINANCE NO. 24-1520

WHEREAS, the corporate authorities of the Village of Westville are authorized to regulate and prohibit nuisances within the Village, and;

WHEREAS, the Village has determined that it is in the best interest of the Village and it's residents to amend the portion of <u>Chapter 97-119(B) (1)</u>.

NOW, THEREFORE, BE IT ORDAINED by the Village Trustees of the Village of Westville, Illinois as follows:

<u>Section 1</u>. The recitals hereinabove set forth are hereby incorporated by reference.

Section 2. Amendments:

Chapter 97-119(B) (1) is hereby amended to read as follows:

- (1) The Village policy will pay for or reimburse the employee for meals that are not provided with the training/seminar/meeting, limited to the following amount per meal, per day, including tip:
 - (a) Breakfast: \$20.
 - (b) Lunch: \$25.
 - (c) Dinner: \$45.

<u>Section 3.</u> If any section, paragraph, clause or provision of this Ordinance shall be held invalid, the invalidity thereof shall not affect any of the other provisions of this Ordinance.

Section 4. All ordinances in conflict herewith are hereby repealed to the extent of such conflict.

Section 5. If any part of this Ordinance is found to be in conflict with any other Ordinance,

Resolution, motion or order or parts thereof, the most restrictive or highest standard shall prevail.

<u>Section 6</u>. This Ordinance shall be in full force and effect from and after its passage, approval and publication as provided by law.
