ORDINANCE NO. 3337

(BILL NO. 2-2024)

AN ORDINANCE AUTHORIZING THE ACCEPTANCE OF A PROPOSAL FOR PURCHASE OF TWO (2) 2025 MACK DUMP TRUCKS FOR THE PUBLIC WORKS DEPARTMENT, IN ACCORDANCE WITH SECTION 3.20 IN THE HOME RULE CHARTER WHICH REQUIRES AUTHORIZATION OF ACQUISITIONS IN EXCESS OF \$25,000 BY ORDINANCE. (FIRE)

WHEREAS, the Township of Whitehall, Lehigh County, Pennsylvania, is desirous of purchasing two new 2025 Mack GR42BR dump truck cab and chassis with dump body and snowplows for the Bureau of Public Works as a purchase approved in the 2024 Budget; and

WHEREAS, said proposals, which were secured through the Co-Stars Process, have been thoroughly reviewed by the Bureau of Public Works and Township staff; and

WHEREAS, the bid of TransEdge Truck Center of Allentown, PA has been judged by the staff to meet the bid specifications and provide the most economical response to the Township's needs for the Mack cabs and chassis; and

WHEREAS, said apparatus is available for purchase through a recognized and approved Commonwealth bidding process, under the Co-Stars Program (#025-E22-405); and

WHEREAS, the bid of E.M. Kutz, Inc. of Whitehall, PA has been judged by the staff to meet the bid specifications and provide the most economical response to the Township's needs for dump body, plows and spreaders; and


WHEREAS, said equipment is available for purchase through a recognized and approved Commonwealth bidding process, under the Co-Stars Program (#025-E22-399).
