#### **ORDINANCE NO. 1415**

### AN ORDINANCE AMENDING AND SUPPLEMENTING CHAPTER 56, OF THE CODE OF THE BOROUGH OF WILDWOOD CREST, ENTITLED RECREATION COMMISSION, SECTION 56-3, APPROVING AND CONFIRMING RATES AND FEES FOR THE RENTAL OF FACILITIES, PARTICIPATION IN CERTAIN EVENTS AND ACTIVITIES

**WHEREAS**, the Borough Commissioners of the Borough of Wildwood Crest have received a new Rate and Fee Schedule submitted by the Recreation Commission pursuant to their authority as stated in Chapter 56-3; and

**WHEREAS**, the Borough Commissioners have reviewed the Rates and Fees Schedule submitted by the Recreation Commission and approved by the Supervisor of Recreation and are desirous of approving the same.

**NOW, THEREFORE, BE IT ORDAINED** by the Board of Commissioners of the Borough of Wildwood Crest, County of Cape May, New Jersey, as follows:

<u>Section 1.</u> Ordinance 1389, adopted December 28, 2022, that has been codified in the Coe of the Borough of Wildwood Crest as Chapter 56, is hereby amended and supplemented as follows and the attached Rates and Fees Schedule pursuant to Section 56-3(C) of Chapter 56, Recreation Commission, of the Borough Code of the Borough of Wildwood Crest is hereby amended as follows (added language is <u>underlined</u>, deleted language is <u>stricken</u>): See attached Fee Schedule which is incorporated herein as if set forth at length.

<u>Section 2.</u> The remainder of all other sections and subsections of the aforementioned ordinance not specifically amended by this Ordinance shall remain in full force and effect.

**Section 3.** All other ordinances in conflict with or inconsistent with this ordinance are hereby repealed to the extent of such inconsistency.

<u>Section 4.</u> If any portion of this ordinance is adjudged unconstitutional or invalid by a court of competent jurisdiction, such judgment shall not affect or invalidate the remainder of this ordinance, but shall be confined in its effect to the provision directly involved in the controversy in which such judgment shall have been rendered.

Section 5. This ordinance shall become effective twenty (20) days after final passage and advertisement thereof as required by law.
