ORDINANCE 2015 –09**

**AN ORDINANCE TO AMEND AND SUPPLEMENT  
CERTAIN PROVISIONS OF CHAPTER 210 ENTITLED  
“VEHICLES & TRAFFIC” OF THE CODE OF THE  
BOROUGH OF WRIGHTSTOWN**

**WHEREAS**, the Borough of Wrightstown continually undertakes to review safety conditions on the Borough’s roadway system as part of its long term goal to improve safety conditions on the Boroughs roadways and neighborhoods; and

**WHEREAS**, the safety of Borough residents and members of the general public utilizing Borough roads are threatened and endangered by certain trucks 10,000 lbs. gross weight and over making left hand turns from Farago Boulevard onto Saylor’s Pond Road

**NOW THEREFORE, BE IT ORDAINED AND ENACTED** by the Borough of Wrightstown, County of Burlington, State of New Jersey, that (“Excavations in Streets”), of the Code of the Borough of Wrightstown be and is hereby amended and supplemented as follows:

Section One Article VI Section 210-42, Schedule XIV is hereby amended and supplemented to add the following provision:

**Supplemental Section.**

- A. Trucks registered at 10,000 lbs. gross weight or over are hereby prohibited from making left-hand turns from the entire length of Farago Boulevard onto Saylor’s Pond Road.

**Section Two. Repealer, Severability and Effective Date.**

- A. Repealer. Any and all Ordinances inconsistent with the terms of this Ordinance are hereby repealed to the extent of any such inconsistencies.
- B. Severability. In the event that any clause, section, paragraph or sentence of this Ordinance is deemed to be invalid or unenforceable for any reason, then the Township Committee hereby declares its intent that the balance of the Ordinance not affected by said invalidity shall remain in full force and effect to the extent that it allows the Township to meet the goals of the Ordinance.
- C. Effective Date. This Ordinance shall take effect upon proper passage in accordance with the law.

**NOTICE IS HEREBY GIVEN** that the above Ordinance was introduced and passed on first reading at the Regular Meeting of the Borough Council of the Borough of Wrightstown in the County of Burlington, State of New Jersey held in the Borough Hall on October 28, 2015 and the same came up for final passage at the Regular Meeting of the Borough Council held on November 24, 2015, at which time, after persons interested were given an opportunity to be

heard concerning said Ordinance, the same was passed and will be in full force in the Borough according to law.
