

**BOROUGH OF WRIGHTSTOWN
ORDINANCE NO. 2010-08**

**ORDINANCE OF THE BOROUGH COUNCIL OF THE BOROUGH OF
WRIGHTSTOWN AMENDING CHAPTER 122, BEING THE NOISE CHAPTER,
OF THE CODIFIED ORDINANCES OF THE BOROUGH OF WRIGHTSTOWN**

BE IT ORDAINED AND ENACTED, by the Borough Council of the Borough of Wrightstown, County of Burlington and State of New Jersey, as follows:

Section 1: Chapter 122, Noise, of the Codified Ordinances of the Borough of Wrightstown shall be and is hereby amended to read as follows:

...

§ 122-5. Appeal from denial of permit.

An applicant for a permit hereunder shall have the right to appeal to the Borough Council from the denial of the permit by the issuing officer. Such appeal shall be taken by filing a written notice of appeal addressed to the Borough Council. Such notice shall be filed within five (5) days after the issuing officer shall have notified the applicant of the denial of the permit. The Borough Council shall act upon the appeal as soon as practicable after receiving the notice thereof and shall give the applicant an opportunity to be heard before taking action. The Borough Council may affirm or reverse the issuing officer's denial of the permit or may grant the permit with modifications or conditions.

...

Section 2: All ordinances or parts of ordinances which are inconsistent herewith are hereby repealed to the extent of their inconsistency.

Section 3: This Ordinance shall take effect immediately after proper passage, publication, and approval as provided by law.
