Mayor Dunwell led prayer and the salute to the flag.

BOROUGH OF ALPHA
RESOLUTION FOR TONNAGE GRANT APPLICATION**

WHEREAS, the Mandatory Source Separation and Recycling Act, P.L.1987, c.102, has established a recycling fund from which tonnage grant may be made to municipalities in order to encourage local source separation and recycling programs; and

WHEREAS, it is the intent and the spirit of the Mandatory Source Separation and Recycling Act to use the tonnage grants to develop new municipal recycling programs and to continue and to expand existing programs; and

WHEREAS, the New Jersey Department of Environmental Protection has promulgated recycling regulations to implement the Mandatory Source Separation and Recycling Act; and

WHEREAS, the recycling regulations impose on municipalities certain requirements as a condition for applying for tonnage grants, including but not limited to, making and keeping accurate, verifiable records of materials collected and claimed by the municipality; and

WHEREAS, a resolution authorizing this municipality to apply for the **2016 Recycling Tonnage Grant** will memorialize the commitment of this municipality to recycling and to indicate the assent of the Council of the Borough of Alpha to the efforts undertaken by the municipality and the requirements contained in the Recycling Act and recycling regulations; and

WHEREAS, such a resolution should designate the individual authorized to ensure the application is properly completed and timely filed.

NOW THEREFORE BE IT RESOLVED by the Council of the Borough of Alpha that the Borough of Alpha hereby endorses the submission of the recycling tonnage grant application to the New Jersey Department of Environmental Protection and designates Tom Fey, Recycling Coordinator to ensure that the application is properly filed; and

BE IT FURTHER RESOLVED that the monies received from the recycling tonnage grant be deposited in the grant fund and be used solely for the purposes of recycling.

C-2 OPERATOR APPOINTMENT**

WHEREAS, the Borough of Alpha is required to have a Licensed Sewer Collection System Operator, also known as a licensed C-2 sewer operator, by the State of New Jersey.

NOW THEREFORE, BE IT RESOLVED, by the Governing Body of the Borough of Alpha, County of Warren, State of New Jersey that John Manganaro of Water Resource Management, a subsidiary of Remington and Vernick Engineering, is hereby appointed C-2 Sewer Operator for the Borough of Alpha, duly licensed by the State of New Jersey at an annual rate of \$15,000.00 to be pro-rated for the calendar year 2017, upon certification of funds by the Borough CFO. This appointment shall be effective April 1, 2017.

BE IT FURTHER RESOLVED, that this is awarded without competitive bidding as a “professional service” under the provisions of the Local Public Contract Law as provided by *NJSA 40A: 11-5* because it requires service performed by a person authorized by law to practice as a recognized profession and it is not possible to obtain competitive bids.

2. The Borough of Alpha made an attempt to sell the property at auction after having duly advertised same. No one bid on the property. Therefore, Council authorizes destruction of the property.

Approval of Minutes

Mayor Dunwell asked that the regular meeting for 2013-16 be tabled, all were in favor.

Department Reports

Administration, Councilwoman Tracy Grossman, gave the following report in Councilwoman Gable’s absence: No report.

In closing, Councilwoman Grossman approved bills, salaries and wages for her department.

Finance, Councilman Mike Schwar, reported that the tax collector will be out of office 4/14-4/19 and that will affect utility collections. Councilman Schwar also reported that state aid will not change from last year and we will still be receiving \$225, 747.00. Councilman Schwar stated that the CFO has been out all week with the flu. Councilman Schwar requested 10 minutes in executive session for contractual and personnel.

In closing, Councilman Schwar approved bills, salaries, and wages for his department.

Health and Welfare, Councilman Thomas Seiss, gave the following report in Councilman Pettinelli's absence: No report.

Public Property, Councilwoman Tracy Grossman, reported that the engineer's report states that they will be replacing portions of the Benke Field roof. Councilwoman Grossman also stated that she is looking into getting a double door shed for Benke field that could possibly double as a concession stand. Councilwoman Grossman also stated that she received a phone call from Alyse Fegley and was informed that the school board is no longer interested in sharing services with other districts. She stated that they are looking to hire their own chief school administrator/superintendent. Councilwoman Grossman also stated that the school is planning to have a Q&A on 3/27 for the public and she will be bringing flyers into the municipal building. Councilwoman Grossman requested 15 minutes in executive session for contractual.

In closing, Councilwoman Grossman stated she would like to hold the Remington & Vernick bill until next meeting but has approved all other bills, salaries and wages for her department.

Public Safety, Councilman Thomas Seiss, reported that the crossing guard has completed mandatory training with the police chief and Monday she will shadow our current crossing guard. Councilman Seiss also reported the roll call of the Alpha Volunteer Fire Company as follows: Fire Chief; Sean McDyer, Assistant Chief; Mike Sebring, Captain; Steve Dragotta, Lieutenants; Randy Stein, Brandon Hanics, and Maurice Badway. Safety Officer; Ed Hanics, Drivers; Charles Bodogh, Debbie Bodogh, Pete DeMarco, Robert Gable, Robert A. Gable, George Gall, Carl Gertsey, Mike Messey, Jeff Milan, Nick Rodalgo, Joe Schoko, Scott Turdo, and alternates Joel Lay and Jeff Fey. Fire Police: Chief; Robert Plimpton, Robert Stamets, Steve Mammolly, Jack Batey, and John Clymer.

In closing, Councilman Seiss approved bills, wages and salaries for this department.

Public Works, Councilman Louis Cartabona, reported that we have received our new mason dump in preparation for the last snow storm. He stated the mayor has been looking for quotes to have snow plow equipment installed. Councilman Cartabona reported that the DPW has been working on salting the roads and snow removal. He

stated that in addition to the DPW workers, the emergency equipment operator, two part time workers, and two hired contractors have been working to clean the municipal building parking lot and the firehouse parking lot. Councilman Cartabona also reported that the DPW has been working with the contracted company on the water utility project on an as needed basis.

In closing, Councilman Cartabona approved bills, wages and salaries for this department.

Councilman Seiss made a comment regarding snow removal on High Street near the bridge for the school safety route.

Mayor Dunwell reported that he had few complaints regarding snow removal. One complaint was on Peach and Alpha Streets, and the DPW took care of the issue. Mayor Dunwell commended the DPW for a good job on removing the snow. There were different discussion of complaints and instances that occurred after the snow storm involving snow removal. Mayor Dunwell stated that the Almond Tree Manor made their parking lot available for residents on 5th Avenue to park there during snow removal which helped out the DPW.

Councilman Cartabona requested 5 minutes in executive for contractual and public property.

Professionals and Officials Reports

Mayor: Mayor Dunwell reported that there was a loose wire for the municipal building heating system which caused there to be no heat on the right side of the building. A local HVAC company came in and repaired the issue. Mayor Dunwell commented on the ordering of a dump truck with a plow for the DPW department. He stated that after communication with the car dealer they decided it was best to put the plow on hold due to issues with the plow not holding up. Mayor Dunwell also reported that he went to the DMV to pay for title transfer and was charged a large sum. He later called Trenton and found out that public entities in the state of NJ do not pay to register vehicles and he will be refunded after submitting a form.

At this time, Councilwoman Grossman made a comment about residents posting on the Borough Facebook page with complaints of not having water and not being notified of it. Councilwoman Grossman suggested that contractors should be penalized

for not notifying residents. Mayor Dunwell commented that there have been times where the contractors have wanted to perform work without notifying residents and were told that is not acceptable. He stated that there have been a few instances where he has gotten complaints regarding this issue, so he has suggested the contractors to put notifications in side and front doors if possible so they aren't missed.

Attorney, Christopher Troxell: No report.

Sewer, Jim Hill: inaudible.

Second Public Comment

Joey Foor, Morris Street, advised that there is a manhole in front of his house that becomes more agitated when trucks plow over it.

George Cupon, Sampson Avenue, advised that his neighbors reported not having water last Saturday and were not notified.

Edward Smith, 5th Ave, inquired about the lighting on the war memorial.

Payment of Bills and Claims

Councilman Cartabona made a motion to make the director's report a part of the minutes. Councilwoman Grossman seconded the motion, all were in favor.

At this time, Councilman Cartabona motioned that Resolution 2017-62 be approved before moving further.

Motion made by Councilman Cartabona to approve resolution 2017-62, motion seconded by Councilman Grossman. Roll call; Ayes: Cartabona, Grossman, Schwar and Seiss.

**RESOLUTION 2017-62
AGREEMENT BETWEEN THE BOROUGH OF ALPHA AND B. CHARLES
OLAH, AKA CHARLES B. OLAH, REGARDING PAYMENT FOR UNUSED
SICK TIME AT THE TIME OF RETIREMENT**

WHEREAS, the Borough of Alpha previously entered into a collective bargaining agreement on or about June 23, 2015 which remained in effect throughout 2016, including the retirement date of B. Charles Olah; and

WHEREAS, the sick time provision in the collective bargaining agreement states: “[a]t the time of retirement in good standing, a full time employee shall receive credit or cash for the full value of one-half (1/2) of the earned unused sick days up to one hundred (100) days (paid), not to exceed the maximum established by state law or action, which is currently \$15,000.00 (maximum);” and

WHEREAS, employee B. Charles Olah retired in December 2016 having a balance of at least 312 sick days unused, which has been verified by the Borough Clerk, CFO and governing body; and

WHEREAS, Alpha has agreed to reimburse the retired employee, B. Charles Olah the maximum amount of \$15,000.00 for unused sick time pursuant to the calculations as permitted under the collective bargaining agreement under the provisions set forth thereunder; and

WHEREAS, the Borough Clerk, CFO and governing body hereby verify that the said amount is in lieu of used sick time, as permitted under the applicable collective bargaining agreement, and that nothing further is owed to the retired employee pursuant to his retirement.

NOW, THEREFORE BE IT RESOLVED, by the Council of the Borough of Alpha, County of Warren, State of New Jersey that Alpha agrees to the terms set forth herein between the Borough of Alpha and B. Charles Olah dated March 16, 2017, and;

BE IT FURTHER RESOLVED, that the Mayor, Borough Clerk, and/or Borough Attorney are authorized to execute all necessary documents to effectuate the terms of the above-referenced payment.

Councilwoman Cartabona made a motion that the CFO be authorized to pay all bills authorized by the director. Councilwoman Grossman seconded the motion. Roll call: Ayes; Cartabona, Grossman, Schwar, and Seiss. Nays: none.

Councilman Seiss made a motion that the CFO be authorized to pay all salaries and wages approved by the director. Councilman Cartabona seconded the motion. Roll call: Ayes: Cartabona, Grossman, Schwar, Seiss. Nays: None.

New Business

Councilman Seiss reported that the Fire Company will be holding a pork and sauerkraut dinner on 3/26.

At this time, Mayor Dunwell requested 15 minutes in executive session for contractual and personnel.

Executive Session

Councilman Schwar made a motion to approve the following resolution to go into executive session for forty five minutes for contractual, personal property, and personnel. Motion seconded by Councilwoman Grossman, all were in favor.

EXECUTIVE SESSION RESOLUTION

WHEREAS, Section 8 of the Open Public Meetings Act, Chapter 231, P.L. 1975, permits the exclusion of the public from a meeting in certain circumstances; and

WHEREAS, this public body is of the opinion that such circumstances presently exist.

1. The public shall be excluded from discussion(s) of the hereinafter specified subject matter(s).
2. The general nature of the subject matter(s) to be discussed is: Personnel, and/or Contractual,
3. It is anticipated at this time, that the above stated subject matter(s) will be made public when it is no longer a matter of confidentiality.
4. Action may or may not be taken after executive session.

NOW THEREFORE BE IT RESOLVED, by the governing body of the Borough of Alpha that the public shall be excluded from an executive session for approximately forty five minutes, allowing for a five (5) minute recess between the regular session and the executive session.

Return to Regular Session

Motion made by Councilman Cartabona to return to regular session, motion seconded by Councilwoman Grossman, all were in favor.

Councilman Schwar wanted opinions from council to see if they found it necessary to hold another budget meeting since they have the final budget from the state.

Motion made by Councilman Cartabona to approve resolution 2017-63 with amendment, motion seconded by Councilman Schwar. Roll call: Ayes; Cartabona, Grossman, Schwar, Seiss. Nays: none.
