Sussex County Water Quality Advisory Committee - Municipal Representative; Mayor Blackburn explained that Andover Township did not currently have a representative and wished to appoint volunteer Peter Spinney to the position of SWAC. Mr. Walsh moved to approve the appointment, there was a second and the motion was passed with all in favor.

Mr. Bensley: Mr. Bensley reported on 6th and 7th grade dance on Friday night.

Ms. McGovern:

Reported that the Board of Education chose a new superintendent, Matthew Beck, he will start in July of this year. She announced that the Andover Seniors chose a new senior of the year, she is Dolores Rescovac and there is luncheon scheduled for next Monday.

The Open Space committee is awarding to the Boy scouts the opportunity to work on badges by cleaning up the parking area and to work on benches for Lake Iliff Access. The Open Space committee will meet Wednesday night.

The Sustainable Andover Commission met two weeks ago and discussed the idea of meadow scaping, so you do not have to mow grass. They are interested in the fenced area at Hillside Park to plant grasses indigenous to the area and build upon it each year, specifically plants such as Milkweed. Tom Walsh suggested planting at the catch basins. She will discuss with Darren Dickinson about where he think the meadow scaping would be best.

Mr. Burke: Reported that the Fire Department wet down is scheduled for June 11. He also reported that the Police Department received a grant and there are poster contests at the school for bike helmets. Officer Haggerty earned Child safety seats certification. Safety Town is scheduled for July 2016.

Mr. Walsh: Reported on the new concrete flooring at the pavilion at Park, grills to be put in this week on the pad. The grills and picnic tables came from the recycling grant. The DPW is working on lower level of barn for new tenants. The Courts will be next, first the basketball court, then tennis. Steve Benziger's family requested to plant a tree at the park on Father's Day in memory of Steve. The new prospective owner of Wards Gift Shop has been informed by the DEP that the property is in a floodplain.

Ms. Blackburn: Reported that the Environmental Commission met and are currently working on GEOTOURISM specifically a township trail map for the kiosks. Dan Freed, Sussex County is working with them. They also want to pursue the Old Creamery property however it has a current NJDEP lien and may not be worth it.

REPORT FROM THE CLERK/ADMINISTRATOR

The clerk clarified for the committee the duties of the Registrar's office and that not only do we provide services to our own residents but we handle all the applicants for all marriages, deaths and births occurring in Andover Township

A \$250 safety award has been granted to the DPW for their safety track record. She added that the employees would like to make a donation to the Benziger Foundation.

REPORT FROM THE MUNICIPAL ATTORNEY

Mr. Semrau suggested the Clerk put the Creamery Property on the executive session agenda next meeting to go over the legal issues and brief history of the property.

He reminded the committee to be sure to take the elected official's course, it is available online.

He reported that he met with Cory Stoner, Township's Engineer and the County of Sussex, Department of Engineering to discuss the several waivers needed for the access area. They granted the application and Mr. Semrau congratulated Mr. Stoner for a job well done.

He further reported that less than thirty residential tax appeals have been filed. The Revaluation Company will defend the appeals.



RESOLUTION OF THE TOWNSHIP OF ANDOVER, COUNTY OF SUSSEX AND STATE OF NEW JERSEY, AUTHORIZING THE SALE OF CERTAIN LANDS AND PROPERTIES WHICH ARE NO LONGER NEEDED FOR PUBLIC USE BY THE TOWNSHIP

WHEREAS, the Township of Andover is the owner of certain lands and premises within the Township of Andover; and

WHEREAS, the Mayor and Township Committee of the Township of Andover does hereby determine that the lands and properties set forth in Schedule A are no longer needed for public use; and

WHEREAS, the Township of Andover desires to make available for public sale said lands, with the right of prior refusal to be afforded to adjacent property owners pursuant to N.J.S.A. 40A:12-13.2.

NOW, THEREFORE, BE IT RESOLVED, by the Township Committee of the Township of Andover as follows:

1. The Township of Andover hereby declares that the lands and premises set forth in Schedule A are no longer needed for public use and should be sold in accordance with appropriate statutes of the State of New Jersey.
2. The Township Committee of the Township of Andover hereby authorizes the Township Clerk/Administrator to offer for sale to the highest bidder by open public sale at auction the property set forth in Schedule A below and made a part hereof.
3. The public sale shall take place at the Andover Township Municipal Building, 134 Newton Sparta Road, Newton, New Jersey, 07860 on July 11,, 2016 at 5:00 p.m. or as soon thereafter as the matter can be heard and publicly announced, provided the sale is not cancelled.
4. The public sale, if not cancelled, shall take place by open public sale at auction to the highest bidder.
5. The successful bidder at the time of the sale must present cash or a certified check or money order, payable to the Township of Andover, in an amount that equals 10% of the assessor's suggested minimum sales price. This deposit shall be non-refundable. The balance of the purchase price shall be paid to the Township no later than sixty (60) days following the acceptance by the Township and the tender of marketable title to the purchaser and submitted to the Township. The purchaser shall be entitled to possession immediately following closing of title.
6. The Township makes no representation as to the title or any other aspects of the land to be sold, including utility, sewer or environmental conditions.
7. At closing of title, purchaser shall also pay to the Township a buyer's premium in the amount of ten (10%) percent of the bid amount.
8. The Township reserves the right to accept or reject any and all bids at the public sale and not to award to the highest bidder. Such decision will be made by the Township Committee at a Public Meeting within 30 days from the date of such sale.
9. In the event the Township of Andover is unable to convey clear and marketable title, insurable at regular rates by a title insurance company authorized to do business in the State of New Jersey, the Township shall forthwith return to the purchaser the deposit and neither party shall have any further rights against the other. The acceptance of a deed by the purchaser from the Township shall extinguish any claims the said purchaser may have against the Township of Andover in connection with the quality of title conveyed.
10. All conveyances by the Township shall be made by way of a Quit Claim Deed, unless an adequate title binder prepared at the expense of the purchaser is forwarded to the Township prior to the conveyance and discloses that the Township holds marketable title in which case a Bargain and Sale Deed with Covenants Against Grantor's Acts will be the form of conveyance. WHEREAS, the Township Committee wishes to award a contract to Farmside Landscape & Design in accordance with the proposal attached hereto as Exhibit A; and


WHEREAS, the Chief Financial Officer of the Township of Andover has certified that sufficient funds are available for this purpose.

BE IT FURTHER ORDAINED that the period of usefulness of the improvements is in excess of the five (5) year statutory requirement, and that no debt shall be incurred by the Township for this improvement authorization.

The total amount of \$40,000.00 is hereby appropriated from the Capital Improvement Fund – Fire Truck

The Chief Financial Officer hereby certifies the aforementioned funds are available.

This ordinance shall take effect immediately upon passage and publication in accordance with the law.
