**ORDINANCE OF THE ANDOVER TOWNSHIP COMMITTEE TO
AMEND AND SUPPLEMENT CHAPTER 51 "FIRE PREVENTION",
SECTION 51-3 "PERMIT FEES" OF THE REVISED GENERAL CODE
OF THE TOWNSHIP OF ANDOVER**

WHEREAS, the Uniform Fire Safety Act, N.J.S.A. 52:27D-192 et seq., authorizes municipalities to establish fees, by ordinance, to cover the cost of conducting inspections by local fire officials pursuant to the Act;

WHEREAS, the State of New Jersey has also established fees, by regulation, for obtaining fire permits and certificates of smoke detector and carbon monoxide alarm compliance (ACSDCMACs@); and

WHEREAS, the fees established by the State of New Jersey for obtaining fire permits and CSDCMACs set forth in N.J.A.C. 5:70-2.9(c) and (d) are periodically revised and have recently been increased; and

WHEREAS the Township of Andover is desirous of revising its fees for obtaining fire permits and CSDCMACs to comport with the changes made to the amounts set forth at N.J.A.C. 5:70-2.9, and deems it to be in the public interest to provide that those fees be automatically adjusted in the future at such time as the State of New Jersey may adjust the fees contained within N.J.A.C. 5:-70-2.9; and

NOW, THEREFORE, BE IT ORDAINED by the Township Committee of the Township of Andover, County of Sussex, State of New Jersey as follows:

Section 1. Section 51-3 of the Code, entitled "Permit Fees", is hereby amended to read as follows:

In connection with the provisions of this chapter and the fire protection code, the following permit fees shall be charged and received by the clerk:

FIRE PERMIT TYPE

TYPE 2	\$ 166.00
TYPE 3	\$ 331.00
TYPE 4	\$ 497.00

CSDCMAC

INSPECTION FEE

Inspection requested more than 10 business days prior to change of occupant.	\$ 35.00
Inspection requested 4 to 10 business days prior to change of occupant.	\$ 70.00
Inspection requested fewer than 4 business days prior to change of occupant.	\$ 125.00
Re-Inspection Fee	\$50.00

The permit fees listed above shall be as provided by state regulations, presently set forth at N.J.A.C. 5:70-2.9 (c) and (d), and are subject to change whenever the fees contained in those regulations are adjusted.

Section 2. All ordinances or parts of ordinances inconsistent herewith are hereby repealed.

Section 3. If any section, subdivision, sentence, clause or provision of this Ordinance shall be adjudged invalid, such adjudication shall apply only to the section, paragraph, subdivision, clause or provision so adjudged and the remainder of the Ordinance shall be deemed valid and effective.


Section 4. This Ordinance shall take effect upon final passage and publication as provided by law.
