Ms. McGovern: Ms. Mc Govern met with Darren Dickinson and Cory Stoner regarding Open Space projects. Bids are due on the Lake Iliff Access parking lot apron, the basketball court and walkways, at the park and Goodale Road parking lot on June 22.

She discussed questions she had about the tennis courts, and further explained that they were installed in 1980, and resurfaced once before and then again in 2016. It's not perfect, and is probably not going to be any better than it is currently without total reconstruction.

Ms. Blackburn: The Environmental Commission had met and reviewed the application for Combined Energy Systems.

Ms. Blackburn and Jack Burke had attended the Sussex County Economic Development Partnership awards luncheon at Perona Farms. Andover Township had won the municipal award. The award had been presented by Jackie Espinoza for attracting area businesses such as Pace Glass, Homers, AG Pizzeria and Combined Energy Systems which greatly improved the properties. Also, SCEDP recognized the township's efforts regarding the Lackawanna Cutoff.

Mr. Walsh: Mayor Walsh thanked Gigi Regolizio and Jim Holmes for all the worked that they did. They really spearheaded the whole show. He asked if he could get a list of all the donors and vendors for participating.







WHEREAS, in the course of this project, NJ Transit has indicated that it requires access to certain property to upgrade, construct, monitor and maintain a culvert located in the vicinity of the proposed train station in Andover Township; and

WHEREAS, NJ Transit has advised that they, by policy, will not proceed with eminent domain actions in order to obtain access or acquire property for the purposes of this project; and

WHEREAS, NJ Transit has also advised that without this access, the present completion of the project is "on hold" until this has been resolved; and

WHEREAS, the Township of Andover, in an effort to support the completion of the Lackawanna Cut-Off Transportation Project for the benefit of the residents of the Township and Sussex County, will undertake necessary action for the temporary and/or permanent acquisition of land for the purposes of completing the Lackawanna Cut-Off Project; and


WHEREAS, the Township proposes a Memorandum of Understanding between NJ Transit and Andover Township that calls for reimbursement for all costs incurred by Andover Township in the event the Township were to take the lead and take necessary legal steps to acquire the temporary and/or permanent interest in lands adjacent to the proposed Andover Township Station.

NOW, THEREFORE, BE IT RESOLVED, by the Mayor and Township Committee of the Township of Andover, County of Sussex, and State of New Jersey as follows: the Mayor is hereby authorized to enter into an agreement on behalf of the Township with NJ Transit for the purposes of the Township taking necessary steps which may include an eminent domain action for the permanent or temporary easement for a small area of land located near the proposed Andover Township Train Station; and

BE IT FURTHER RESOLVED, that this agreement is in consideration of the Township of Andover being reimbursed for any and all reasonable costs relating to this necessary action.
