**ORDINANCE NO. 15 - 10**

**AN ORDINANCE OF THE BOROUGH OF BELLEVUE, A HOME RULE MUNICIPALITY IN THE COUNTY OF ALLEGHENY, IN THE COMMONWEALTH OF PENNSYLVANIA; AMENDING ORDINANCE 93-20 IN ORDER TO ALTER METERED PARKING REGULATIONS AND THE PARKING OF VEHICLES WITHIN SAID METERED PARKING AREAS**

**BE IT ORDAINED AND ENACTED** by the Borough Council of the Borough of Bellevue, in the County of Allegheny and Commonwealth of Pennsylvania, and it is hereby ordained and enacted by the authority of the same, in accordance with the provisions of the Act of Assembly of the Commonwealth of Pennsylvania, as follows:

**SECTION 1:** Section IV(B) of the Bellevue Borough Ordinance 93-20 shall be deleted and replaced with the following:

“B. Those meters situated along public streets having a limit of two (2) hours:  
Twenty-five (25) cents for one (1) hour or a fraction thereof.”

**SECTION 2:** Section IV(C) of the Bellevue Borough Ordinance 93-20 shall be deleted and replaced with the following:

“C. Those meters situated along public streets having a limit of four (4) hours:  
Twenty-five (25) cents for one (1) hour or a fraction thereof.”

**SECTION 3:** Section IV(D) of the Bellevue Borough Ordinance 93-20 shall be deleted and replaced with the following:

“D. Twenty-five (25) cents for one (1) hour or a fraction thereof.”

**SECTION 4:** Section II of Bellevue Borough Ordinance 93-20 shall be amended to include the following:

“C. Metered Parking Areas limited to four (4) hour continuous parking:

1. **Lot 3** (that parking lot situated at the northeasterly corner of Lincoln Avenue and North Jackson Street). Provided, however, there shall be created no less than one (1) but no more than four (4) spaces which are designated with a limit of fifteen (15) minutes which are located in close proximity to Borough businesses.”

**SECTION 5:** Section II of Bellevue Borough Ordinance 93-20 shall be amended to include the following:

“D. Metered Parking Areas limited to eight (8) hour continuous parking:

1. **Lot 1** (that parking lot situated between Hawley Avenue and North Sprague Avenue.”
2. **Lot 2** (that parking lot situated between Meade Avenue and South Sprague Avenue at or near Lincoln Way).”

**SECTION 6:** Section II of Bellevue Borough Ordinance 93-20 shall be amended to include the following:

“E. There are hereby created, in those parking spaces or already in existence within the Borough of Bellevue, fifteen (15) spaces in Lot 2 (that parking lot situated between Meade Avenue and South Sprague Avenue at or near Lincoln Way) which are designated and reserved as permit parking only spaces for monthly pass holders and residential parking permit holders. The permitting fee(s) shall be in an amount as determined by the Borough Council by resolution in order to cover the administration and review of the specific permit application.”


**SECTION 7:** Section II of Bellevue Borough Ordinance 93-20 shall be amended to include the following:


"F. The erection and maintenance of all necessary signage is hereby authorized. Said signage shall be placed so as to properly notify all vehicular traffic of the imposed regulations."

**SECTION 8:** Any ordinance, or part thereof, conflicting with the provisions of this ordinance is hereby repealed insofar as the affects this ordinance.


