

BOROUGH OF BELLEVUE

ORDINANCE NO. 89- 4

AN ORDINANCE OF THE BOROUGH OF BELLEVUE, A HOME RULE CHARTER MUNICIPALITY, LEVYING AND ASSESSING A FEE OF \$25.00 FOR ANY CHECK DRAWN IN PAYMENT OF ANY FINE, COSTS IN LIEU OF FINE, STATEMENT OF AMOUNT DUE THE BOROUGH OF BELLEVUE, FEES, WHETHER IMPOSED BY ORDINANCE OR OTHERWISE, PAYMENT OF TAXES, REAL ESTATE AND OTHER TAXES, DELINQUENT SEWER BILLS WHICH IS RETURNED BY THE DRAWER'S BANK AS "IMPROPERLY DRAWN," "NOT SUFFICIENT FUNDS," "ACCOUNT CLOSED," "POST DATED," "STALE DATED," "DEFECTIVE ENDORSEMENT," "DEFECTIVE SIGNATURE," "UNCOLLECTED FUNDS," "PAYMENT STOPPED," "DISCREPANCY IN AMOUNTS," "ACCOUNT FROZEN," "CHECK ALTERED," "INCOMPLETE CHECK," OR ISSUED IN THE PERPETRATION OF A FRAUD; AND ADDING THE SAID FEE OF \$25.00 ONTO THE ORIGINAL AMOUNT DUE.

THE TOWN COUNCIL OF THE BOROUGH OF BELLEVUE HEREBY

ORDAINS:

SECTION 1. The Town Council of the Borough of Bellevue hereby levies and assessed a fee of \$25.00 for any check drawn in payment of any fine, payment on lieu of a fine, statement of amount due the Borough of Bellevue, fees, whether imposes by ordinance or otherwise, payment of taxes, real estate of other taxes, delinquent sewer bills, or any other sum due the Borough of Bellevue which check is returned by the Drawer's Bank as "improperly drawn," "not sufficient funds," "account closed,"

"past dated," "stale dated," "defective signature," "defective endorsement," "uncollected funds," "payment stopped," "discrepancy in amounts," "account frozen," "check altered," "incomplete check," or any check issued in perpetration of a fraud.

SECTION 2. The \$25.00 fee, referred to in Section 1. hereof, is a processing fee levied and assessed by the Borough of Bellevue and shall be added to the original amount due.


SECTION 3. The clerks, officers, collectors, including the Tax Collector, and District Magistrate are hereby authorized and directed to add said fee onto the amount due and to apply the same as reimbursement for processing expenses and costs in the collection of said returned checks.

SECTION 4. The levy and assessment of said fee shall not affect, cancel or void any other remedy, civil or criminal, that the Borough of Bellevue, its clerks, officers, collectors, Tax Collector, and District Magistrate may have against the drawer of said check.


SECTION 5. Any ordinance, or part thereof, conflicting with the provisions of this ordinance is hereby repealed insofar as the same affects this ordinance.
