I. Newly elected Mayor Marburger was sworn in by The Honorable Tara Smith

II. Newly elected Members of Council were sworn in by The Honorable Tara Smith

Newly elected Councilpersons DiTullio, Hause, Pikul, Pritchard and Pennington were given the Oath of Office at this time.

III. Call to Order

At 8:00 P.M. Mayor Marburger called the meeting to order with the Pledge of Allegiance and a Moment of Silence.

IV. Election of President

Mayor Marburger opened the floor for nominations for Council President.

Councilperson Pennington made a nominated Councilperson Hrynda for Council President. Councilperson Saylor nominated Councilperson Fodi for Council President.

MOTION: Councilperson Fodi made a Motion to close the floor for nominations for Council President. The Motion was Seconded by Councilperson Saylor and carried via unanimous voice vote.

Mayor Marburger then asked for the vote for Councilperson Hrynda as Council President. The roll call vote was rejected via four (4) ayes and five (5) nays.

Mayor Marburger then asked for the vote for Councilperson Fodi as Council President. The roll call vote passed via five (5) ayes and four (4) nays.

Council President then asked for the vote for Councilperson Saylor as Council Vice President. The roll call vote passed via five (5) ayes and four (4) nays.
