NOTES:

- a A minimum front yard setback of 20 feet with an average of 25 feet will apply for major subdivision applications.
- b Minimum lot areas and widths shown are per unit for two-family and attached dwelling units
- c For all single-family attached dwelling units, the minimum unit width may be 20 feet with an average width of 22 feet.
- d For two-family and attached dwelling units, the first number indicates the distance between units and the second indicates distance between buildings.
- e Lot sizes may be reduced in accordance with § 225-45D(3).
- f The first number corresponds to base lot coverage while the second applies when utilizing the cluster provisions of § 225-45D(3).
- g Within the Pinelands area, no residential dwelling unit shall be located on a parcel of less than 43,560 square feet unless public sewer is provided.
- h Garden apartments or mixed use developments shall adhere to the bulk standards for SF attached dwellings unless otherwise modified pursuant to § 225-48.
